

💰 Cryptocurrency & Blockchain Coin Definitions

Quick Guide for Angel 8, Prestige 888 & Community Partners

◆ Stablecoin

- **Definition:** A digital asset **pegged to a stable asset** like the U.S. Dollar (e.g. USDC, USDT).
- **Purpose:** Keeps **value consistent**, used for **payments, savings, or hedging against volatility**.
- **Examples:** USDC, USDT, DAI
- **Use Case in Our Ecosystem:** Could be used to **store value**, protect against crypto crashes, or act as a **reserve fund** for P8A or A8U systems.

◆ Utility Token

- **Definition:** A token that provides **access or functionality** inside a specific platform or ecosystem.
- **Not backed by assets**, value based on demand.
- **Examples:** ETH (for gas), A8U (Angel 8 Unity Coin), or Binance's BNB
- **Use Case:** Our **A8U coin** allows users to **interact** with services, pay for listings, or join premium programs.

◆ Security Token

- **Definition:** A digital token that represents **ownership or stake** in an asset, company, or revenue stream.
- Regulated by **securities laws** (like stocks).
- **Examples:** Tokenized real estate, equity shares
- **Use Case:** If we offer **shares in real property or revenue**, we may need **legal compliance** to issue these.

◆ Governance Token

- **Definition:** Gives **voting rights** to holders on decisions (like software upgrades or community funds).
- **Examples:** UNI (Uniswap), AAVE

- **Use Case:** A potential **Angel 8 community voting coin**, giving members a voice.

◆ NFT (Non-Fungible Token)

- **Definition:** A **unique digital item** on the blockchain (not interchangeable).
- Can represent **art, real estate deeds, certifications, collectibles**
- **Examples:** Bored Apes, land titles, or our future Angel 8 badges.
- **Use Case:** Use NFTs for **Angel 8 donation badges, event tickets, custom rewards, or membership access.**

◆ Tokenized Asset

- **Definition:** A real-world asset (like **real estate**, gold, or art) represented by a **digital token**.
- Can be **fractionalized** (sold in small pieces).
- **Examples:** Tokenized \$100K house → 1,000 tokens at \$100 each.
- **Use Case:** Use with **SGA (Synergy Gold Assets)** to back real-world holdings like **land, vehicles, homes**, etc.

◆ Native Coin (or Layer-1 Coin)

- **Definition:** The **primary coin** of a blockchain network. It powers **transactions, gas fees**, or acts as currency.
- **Examples:** XLM (Stellar), XRP (Ripple), ETH (Ethereum)
- **Use Case:** Our **P8A** could act as a native-like currency in our ecosystem for **fast, low-cost payments**.
