About the Phlebotomy Technician Training Program

The **Phlebotomy Technician Training Program** is a comprehensive course designed to equip students with the essential knowledge and **hands-on skills** needed for high-quality **blood collection, specimen handling, and rigorous infection prevention practices.**

Phlebotomy Technicians are an essential part of the healthcare system and can find employment in various clinical settings, including hospitals, clinics, emergency rooms, urgent care centers, doctors' offices, commercial laboratories, and more.

Program Structure and Outcomes

This program combines **classroom instruction, intensive laboratory practice, and supervised clinical training** to ensure professional competency.

- **Core Skills Acquired:** Graduates will master safe and effective patient communication, strict adherence to infection control protocols, and the collection of a variety of specimens, including **urine, blood, throat, buccal, and stool** specimens. Training includes performing high-quality **venipuncture, dermal (capillary) punctures**, and conducting essential **Point-of-Care Testing (POCT)**. Students also acquire fundamental skills in taking vital signs and reporting clinical observations.
- **Certification Eligibility:** Upon successful completion of the program and passing the final exam, graduates **qualify to sit for the National Healthcareer Association (NHA) Certified Phlebotomy Technician (CPT) exam.**
- **Career Advancement:** While national certification through the NHA exam is not always required for entry-level employment, **it is strongly recommended** as it demonstrates competency, provides a competitive advantage in the job market, and supports long-term career growth.

PROGRAM REQUIREMENTS

To successfully graduate from the Certified Phlebotomy Technician Program and qualify to sit for the NHA CPT certification exam, students must:

1. Fulfill a **minimum of 120 clock hours** at the institution or designated clinical locations during day or evening sessions.
2. Achieve a **final passing grade of 70% or higher** in the program.
3. Complete a minimum of **30 successful venipunctures** and **10 successful capillary sticks on live individuals** during the clinical/lab portion of the course.

| PH-100 | Introduction to Phlebotomy & Safety | 16 | This foundational course covers the history and critical role of the phlebotomist within the modern healthcare team and laboratory departments. Students master safety protocols , focusing on OSHA standards including the Bloodborne Pathogens Standard, sharps disposal, and implementation of Standard and Transmission-Based Precautions . Emphasis is placed on proper hand hygiene , use of Personal Protective Equipment (PPE) , and emergency procedures like First Aid and CPR . |
| PH-101 | Medical Terminology & Human Anatomy | 16 | This subject introduces essential medical terminology and an in-depth understanding of human anatomy and physiology , with a focus on systems crucial to blood collection. Key areas include the detailed structure and function of the circulatory system (heart, arteries, veins, capillaries), the composition of blood (plasma, serum, cellular elements), and conditions that impact specimen collection (e.g., patient conditions, fasting, medication). |
| PH-102 | Routine & Advanced | 16 | This core module is dedicated to mastering blood collection procedures . Students learn to select and prepare the appropriate venipuncture |

Critical topics include: Patient Identification, Order of Draw (venous and capillary), site selection, and the proper technique for both venipuncture and capillary/dermal punctures . Special attention is given to collecting blood from pediatric and geriatric patients. |
| PH-103 | Specimen Integrity & Processing | 16 | This course focuses on the critical steps that occur post-collection to maintain specimen integrity . Topics include specimen handling, transportation, and proper storage . Students will be proficient in specimen labeling, centrifugation, aliquoting, and recognizing pre-analytical errors (e.g., hemolysis, hemoconcentration, improper tube use). The module introduces Point-of-Care Testing (POCT) , specialized collections (like blood cultures), and non-blood specimen collection (urine, throat, buccal, stool). |
| PH-104 | Professional Issues & Quality Control | 16 | Students explore the legal and ethical guidelines governing phlebotomy practice. Key areas include HIPAA compliance and confidentiality, patient rights (e.g., informed consent), and the phlebotomist's scope of practice . The course emphasizes Quality Assurance (QA) and Quality Control (QC) measures. Crucially, this course covers the strict Chain of Custody (COC) protocols required for legal and forensic specimens (e.g., drug screens, forensic testing). |
| PH-105 | Phlebotomy Clinical/Lab Experience | 40 | This intensive hands-on course allows students to practice and demonstrate competency in all collection techniques learned in PH-102, utilizing both anatomical trainers and supervised live collection opportunities. To successfully complete this module and qualify for the NHA CPT exam, students must successfully perform a minimum of 30 venipunctures and 10 capillary sticks on live individuals. This module also covers patient assessment, managing complications (e.g., fainting, hematoma), and proper professional communication skills. |

Supplemental Teaching Methods:

In addition to traditional lectures, instructors will employ interactive teaching methods such as PowerPoint presentations, handouts, group activities, role-playing scenarios, video instruction, and demonstrations.



Student-to-Instructor Ratio: 10:1

Clinical Placement Requirements (Mandatory Prerequisites)

Enrollment in the Phlebotomy Technician Program includes a mandatory, hands-on clinical experience (**PH-105**). Clinical training is primarily held within the College's clinical lab, but may be subject to being conducted at an approved external healthcare facility.

The following requirements are contingent upon external clinical site assignment:

- **Mandatory Drug Screening:** All students are required to complete and **pass a mandatory 12-panel urine drug screen** prior to beginning the clinical/lab portion of the course. **The cost of this screening is included in your tuition.**
- **Background Check and Immunizations:** **Advanced Medical NC Training College does NOT mandate a criminal background check or specific immunizations** (such as Hepatitis B, TB, or Flu shots) for all enrolled students.

Consequence of Non-Compliance: Students who **fail to pass the mandatory 12-panel urine drug screen** will be **immediately terminated from the program**, and **no tuition refund will be issued**. Furthermore, students who are selected for an external clinical rotation but fail to meet the facility's specific health or security prerequisites will be unable to complete the clinical hours (PH-105). **Students unable to complete the clinical hours are not eligible for graduation or NHA certification, and no tuition refund will be issued.**

Certifications:

Upon completion of the program, students will have the opportunity to sit for the National Healthcareer Association (NHA) Certification Exam.

Program Objectives:

This training program aims to provide students with the resources and learning opportunities necessary to develop the skills required to excel as phlebotomists through structured classroom instruction, lab work, and clinical experiences that align with current industry standards.

Program Outcome:

Graduates will be equipped with the skills needed to take the NHA Certified Phlebotomy Technician (CPT) exam. This is a certification-level course.

Enrollment Requirements:

Students must provide two forms of identity verification from the following list:

- Government-issued photo ID
- Current non-expired driver's license
- U.S. government-issued military ID
- State-issued identification card
- Current passport (U.S. or foreign)
- Current non-expired federal employment authorization document (EAD)
- Alien registration card
- Current non-expired NC learner's permit
- Signed non-laminated U.S. government-issued Social Security card

Additionally:

- Completed high school or college transcripts, must have a graduation date (via Parchment.com or cfnc.org)

The student's identity will be verified through two acceptable forms of identification. Copies will be maintained in student records. The institution is not responsible for students who fail to pay their registration fees promptly after receiving notice of class availability.

Advanced Medical NC Training College reserves the right to evaluate special cases and refuse admission when deemed necessary for individual or program integrity.

Emergency and Make-Up Policy

- **Emergencies:** In case of unavoidable emergencies (e.g., family death, severe weather), students must **inform the instructor prior to class** to avoid penalties. Repeated emergencies may lead the Director to consider these absences as derogatory marks.
- **Make-Up Work:** Students who miss allowed class or lab/clinic time will be assigned a make-up day at the instructor's discretion, with **no additional fees incurred**, to fulfill the 120-hour requirement.

Class Cancellation:

Advanced Medical NC Training College reserves the right to cancel classes due to insufficient enrollment or instructor absence. Students will be notified and offered alternative class dates. Instructors may also cancel classes due to weather-related issues, illness, or emergencies.



ENROLLMENT AND ADMISSION

Admission Policy

Admission to Advanced Medical NC Training College is open on a first-come, first-served basis. We do not discriminate based on race, color, creed, religion, age, sex, national origin, payment source, or physical disability status—except where age or physical disabilities are bona fide occupational qualifications. Our institution is committed to providing equal opportunities and does not tolerate discrimination against students or employees.

Admission Requirements (Mandatory Revisions)

Prospective students must meet the following mandatory criteria:

- Students must be at least 18 years old prior to the scheduled program start date. Students under 18 must have parental permission to enroll.
- Provide proof of high school or college transcripts.
- Successfully complete and pass the mandatory 12-panel urine drug screening (cost is included in tuition).

Acceptance Notification

Each accepted student will receive an email confirmation of their registration.

Student Responsibilities

Students are responsible for completing their academic programs and understanding all requirements related to unacceptable behaviors and minimum knowledge necessary for graduation. All required aspects of the course, including the mandatory practical experience (30 venipunctures/10 capillary sticks), must be completed successfully in order to graduate and take certifying exams.

Course Withdrawal (Mandatory Revision)

If a student needs to withdraw from a course, they must obtain a withdrawal form, complete it, and submit it to the Program Director.

- The official withdrawal date is the date the signed form is received by the Program Director.

- The deadline for a tuition refund (per the Refund Policy) is seven (7) days after the first day of class. After this period, refunds will not be available.
- Failure to submit a withdrawal form or notify the school of departure may result in being dropped from the program with applicable tuition policies enforced.
- Students who withdraw must wait 30 days before re-enrolling in future classes; repeated withdrawals may hinder future enrollment opportunities.

Dismissal Policy

Students will receive counseling regarding behavior issues and violations of the code of conduct prior to dismissal from the program. All counseling sessions will be documented in the student's file by the program coordinator. Dismissal due to inappropriate behavior or unsafe practices will result in no refund.

Procedures for Examination of Records

Students wishing to inspect their educational records must submit a written request. The school will respond within 7 days to schedule a date and time for the inspection, which must occur within 30 days of the request.

Challenge of Student Records

Students may challenge any educational record they believe is inaccurate, misleading, or violates their privacy rights. Such challenges must be submitted in writing and include the reasons for contesting the data in question. The school will investigate the challenge and make necessary corrections within 30 days.

Student Grievance Procedure

Advanced Medical NC Training College is committed to an equitable and prompt resolution of student complaints. This procedure is available to all students who have academic or administrative complaints regarding the school's policies, faculty, or operations.

Step 1: Informal Resolution (Initial Discussion)

The student should first attempt to resolve the matter informally by meeting with the instructor or the staff member directly involved in the complaint within seven (7) business days of the issue's occurrence.



Step 2: Formal Complaint (Program Director Review)

If the complaint is not resolved informally, the student must submit a Formal Written Grievance Form to the Program Director within ten (10) business days of the informal discussion. The written form must include:

- The student's name, contact information, and date of submission.
- A detailed description of the complaint.
- All relevant documentation (emails, dates, etc.).
- The requested resolution.

The Program Director will investigate the complaint and provide a final written decision to the student within fifteen (15) business days of receiving the formal submission.

Step 3: External Resolution (North Carolina State Contact)

If a complaint cannot be resolved through the institution's internal grievance procedure, the student may file a complaint with the appropriate licensing board for private postsecondary institutions in North Carolina.

Privacy Act (FERPA)

The Family Educational Rights and Privacy Act of 1974 (**FERPA**) is a federal law that protects the privacy of students' educational records. Rights under FERPA transfer to students or former students who are **18 years old or older** or who are attending any post-secondary institution. These individuals are referred to as "**eligible students**".

Student Rights

- **Right to Inspect Records:** Parents or eligible students have the right to inspect and review all educational records maintained by the College. Requests must be made **in writing**, and there is a processing fee of **\$15**.
- **Right to Consent to Disclosure:** Generally, the College must obtain **written permission** from a parent (if the student is a minor) or an eligible student (18 or older) before releasing any information from a student's record.

Disclosure Without Consent

FERPA allows colleges to disclose records without consent under certain conditions, including:

- School employees with legitimate educational interests.
- Schools to which a student is transferring.
- Financial aid organizations.
- Certain government officials carrying out lawful functions.
