While this is encouraging, there is still important work to do.

We have specifically asked both the Sevastopol and Jacksonport Town Boards to place the proposed Clark Lake wake surfing ordinance on their July agendas so it can be sent to the Wisconsin DNR for review (emails attached if you have interest in more detail). This is simply the first step in the ordinance process. It starts the required minimum 60-day DNR review period and creates **no risk of litigation**.

Please contact your Town Board representatives by email or phone this week and ask them to place the ordinance on the July agenda.

Feel free to copy and paste this message and add any comments you have - this is an important part of the process:

"Please place the proposed Clark Lake wake surfing ordinance on the agenda for your July meeting so it can be submitted to the DNR for review. This simply begins the required minimum 60-day review process and creates no litigation risk. It will demonstrate that the Town is serious about protecting Clark Lake - thank you."
