## Vendor Rules & Requirements

### General Information

This is a rain or shine event.

There is no access to water or electricity to any vendor.

Each vendor will receive detailed instructions for set up approximately 1 week prior to the event.

### Vendor Eligibility

ALL vendors must carry a minimum of \$1,000,000.00 in insurance for the event with the Edwardsville Hometown Committee as "also named"

If you have questions about this, please contact your insurance agent.

You must also carry a current Pennsylvania Department of Health Certificate, a current Serve Safe Certificate a tax ID# and all current licenses.

Returning vendors must have their application received in hand by April 1<sup>st</sup> to the vendor coordinator. This is to continue your eligibility from the previous year.

**A completed vendor application** consists of completed pages 1 & 3 of this application, vendor fee in the form of a money order made out to Edwardsville Hometown Committee, and a copy of your insurance with the Edwardsville Hometown Committee also named as insured

### General Rules

All vendors will provide their own tents, tables, chairs, equipment.

Tents MUST be weighted, or steaked when possible.

Vendor placement is at the discretion of the Vendor Coordinator. NO DISCUSSIONS

You may not bring products outside of the agreed upon product category on your application.

Each vendor is responsible for securing its own tent, equipment, and inventory.

There will be no overnight security.

Each vendor is responsible for maintaining the condition of their space.

There will be a "Vendor Trash" receptacle available during the event. You may not dispose of any grease at the event, you must take it with you. **Do not** use the customer/attendee trash cans throughout the event space. Leave your space as you found it.

You may not break down earlier than 9:30 each night except for selling out of product.

You may not bring any vehicle onto the grounds during the event, this means **10pm at the earliest**

Vendor must notify the vendor coordinator immediately with any cancellation.

Refunds will not be given after June 8<sup>th</sup>.

No pets allowed in any food vendor space.

Do not encroach on another vendor's space, consider your "line-up" area

Not complying with these rules may result in a forfeiture of your vendor spot.

# 2026 Hold Harmless Clause

Vendor, its officers and members shall hold harmless and defend the Edwardsville Pierogi Festival, its agents, members of the Edwardsville Hometown Committee, Edwardsville Borough and its agents from all liability, judgements, suits, costs, and actions, including attorney fees and all costs of litigation of every kind and description brought or rendered against the Edwardsville Pierogi Festival, its agents, volunteers, and officers as a result of loss, damage, or injury of persons or property by reason of any act or failure to act.
