### Congratulations to the Class of 2025, you are almost to the finish line!

In celebration of the end of high school and beginning of the next phase of life, adulthood, Washoe County Safe N Sober is excited to announce that the Senior Class of 2025 will celebrate Grad Night at the Santa Cruz Boardwalk on June 6, 2025. Participating graduates will check-in starting at 9:00am and board buses beginning at 10:00am. Prior to boarding, all students' bags will be checked and searched by police drug dogs. Food and beverages will be available on all buses and we will make a scheduled stop for lunch en route. Upon arrival Seniors will enjoy beach time and starting at 5:00pm, they will have exclusive access to the Bayview Room and event area for an All-You-Can-Eat buffet dinner, unlimited soft drinks, and a private beach area with tailgate games. They will enjoy a true Senior Sunset at the beach overlooking the ocean. At approximately 9:30pm we will head to the Boardwalk for the Grad Event until 2:00am. All participating graduates will receive a Grad Night school specific sweatshirt, \$20 in Boardwalk Bucks for snacks, unlimited drinks, unlimited Arcade play, and access to fun activities such as henna tattoos and caricature artists. Activities will wrap up at 2:00am when the seniors will be escorted to a conference room to rest until we can board the charter buses. Upon boarding they will be given a variety of breakfast options to enjoy on our ride home. Our expected return time is 10:00am Saturday June 7th. No participating seniors will be allowed to bring any food or drinks on the buses unless specifically approved by the WCSNS committee. Santa Cruz Boardwalk is closed for the special event and regular season passes are not valid for this trip. The park is closed to the general public and tickets can only be purchased through us for this event.

Tickets are now on sale for \$390.00 and must be purchased in advance of the event. Space is limited! Should you choose to participate in the payment plan a deposit of \$40 is required along with monthly payments of \$44.00. If you choose the payment plan option please see payment arrangement coupons. If you choose to pay via credit/debit on the Square link prices include a processing fee.
