EXPECTATIONS FOR FOSTERING WITH KVKR

- 🚗 The kittens/cats must be cared for and loved in an indoor family environment
- 🚗 Existing animals and pets in the home must be kitten/cat friendly
- 🚗 Existing animals and pets **must have CURRENT vaccinations for Feline Upper Respiratory Infection, Feline panleukemia and rabies. If your pets vaccines are not up to date, and your pet gets sick, Kannata Valley Kats Rescue, Inc. is not responsible for vet care for your unvaccinated pets. This is solely at your discretion!**
- 🚗 There should be a safe place for the kittens/cats to go when they need to be apart from the family. A room with a baby gate where they can come and go would be ideal, kennel, ect.
- 🚗 There should be weekly contact with KVK including updates, picture of the kittens/cats that KVK can post and assist with the adoption process
- 🚗 Kannata Valley Kats will supply all provisions for the kittens/cats while in foster care. This will include food, litter box, litter, toys, blankets, vet care.

Accordingly, as a volunteer, you agree to the following conditions: I hereby agree to hold Kannata Valley Kats Rescue Inc., its Officers, Directors, Employees, and Volunteers forever harmless for any damage to personal property or any injury whatsoever that I may suffer as a result of my volunteer activities with Kannata Valley Kats Rescue Inc. **This includes, but is not limited to, bites, scratches, and communicable illnesses or pests contracted from any animal.** Kannata Valley Kats Rescue Inc., strongly recommends that all volunteers have an up to date Tetanus shot. I am aware that as a volunteer of Kannata Valley Kats Rescue Inc., I am acting as a representative of the organization and agree to act responsibly at all times by maintaining a professional demeanor and protecting the rescued animals from any harm while they are in my possession or care. You must be 18 years or older to foster. Fosters under 18 years of age require a parental or legal guardian to fill out the foster waiver. This waiver applies to any and all events and volunteer opportunities that I attend as a volunteer for Kannata Valley Kats Rescue Inc.
