



LIABILITY WAIVER AND RELEASE OF CLAIMS

I, the undersigned participant and/or parent/legal guardian of the participant named below, understand and acknowledge that participation in baseball activities, practices, games, camps, clinics, tournaments, and related events at Benny Petrus Park – Crawford Field involves inherent risks, including but not limited to bodily injury, permanent disability, illness, property damage, and death.

In consideration for being allowed to participate in activities organized, operated, sponsored, or conducted by Crawford Field Sports, LLC and/or The Daniel Harder American Legion Post 48 of Stuttgart, Arkansas, I agree to the following:

1. ASSUMPTION OF RISK

I voluntarily assume all risks associated with participation in baseball and related activities, including but not limited to:

- Being struck by bats, balls, or equipment
- Collisions with players, spectators, fences, or structures
- Slips, falls, or field conditions
- Heat-related illness, weather conditions, or other environmental hazards

- Actions or negligence of other participants, coaches, volunteers, or spectators
- I understand that these risks may result in serious injury or death.

2. RELEASE AND WAIVER OF LIABILITY

I hereby release, waive, discharge, and covenant not to sue:

- Crawford Field Sports, LLC
- Benny Petrus Park – Crawford Field
- The Daniel Harder American Legion Post 48, Stuttgart, Arkansas
- Their owners, officers, directors, employees, volunteers, coaches, agents, sponsors, affiliates, and representatives

from any and all liability, claims, demands, actions, damages, costs, or expenses arising out of or related to any injury, illness, loss, or damage sustained while participating in or attending activities at Benny Petrus Park – Crawford Field, whether caused by negligence or otherwise, to the fullest extent permitted by Arkansas law.

3. MEDICAL AUTHORIZATION

In the event of an emergency, I authorize Crawford Field Sports, LLC, its representatives, coaches, volunteers, or affiliated personnel to obtain medical treatment for the participant if I cannot be reached immediately.

I understand and agree that I am solely responsible for any medical expenses incurred.

4. RULES AND CONDUCT

I agree that the participant will follow all rules, safety instructions, and directions provided by coaches, umpires, staff, and facility personnel. I understand that failure to comply may result in removal from participation without refund.

5. PHOTO AND MEDIA RELEASE

I grant permission to Crawford Field Sports, LLC and The Daniel Harder American Legion Post 48 to use photographs, video recordings, or images of the participant for promotional, advertising, social media, or informational purposes without compensation.

6. SEVERABILITY

If any provision of this waiver is found unenforceable, the remaining provisions shall remain in full force and effect.
