# Background

# **History**

In October 2014, it was agreed upon to start a new, independent non-profit global network of pituitary patient organizations. The goals were to improve communication between patients and healthcare professionals, start a global awareness campaign and survey to collect patient experiences to use as an advocacy tool at a national level. Gaps in diagnoses, treatment and care of patients with pituitary conditions were also highly ranked.

Since this decision was made, the Board of Directors worked on the establishment of the World Alliance of Pituitary Organizations, in short 'WAPO' which became an official entity on May 30th, 2016.

# **WAPO General facts**

- First meeting held in 2012.
- Legally established since 2016 in Amsterdam, The Netherlands.
- WAPO currently has 36 member organizations from 27 countries, amounting to 38% of global population (thus more than 290,000 pituitary patients potentially represented).
- WAPO member organizations have 15,000+ pituitary patient members.
- WAPO Board has 6 directors from 6 countries: Australia, Argentina, Italy, Netherlands, Russia and U.S.A.
- In 2018-19: Board members held 92 e-meetings lasting 73 minutes on average with 5 attendees on average, and 506 manhours total.
- Communication media: www.wapo.org, Facebook, Twitter, regular Newsletter, mailings, annual Summit and AGM.

WAPO's mission is to identify pituitary patient advocacies and guide the development of their organizations as well as creating an active global network

We believe that the strength of a global network of national pituitary patient organizations will lead to improved diagnosis, treatment and care for pituitary and adrenal patients worldwide.

We will consider our mission completed when the patient declaration\* is fully implemented in all countries.

# The Agenda

The 2019 Summit was organized in Lyon, France in order to collaborate with the Nurses of the European Society of Endocrinology during the ECE2019 in Lyon (May 18 – 21, 2019). WAPO organized the program for Friday and Saturday morning at the Novotel Lyon Confluence, while the joint session was held from 12:00 (incl. lunch) – 16:45 at the ECE venue. The joint program was prepared and discussed during the period of July 2018 – April 2019. WAPO focused this year on 'health' related topics, like the 'fitbits' which were handed out and sponsored by 'RecycleHealth' (U.S.A.).



This year Kathy Redmond facilitated the Summit program on Friday and Saturday, both at the WAPO venue as well as the ECE venue. The Sunday AGM was facilitated by Sheila Khawaja.

Also the 'Guidebook' app was prepared for all Summit participants and it included the agenda, Who's Who details, supporting information on the hotel, weather, travel and other supporting information. WAPO invited again the two interpreters Marta Brotto and Alessandra Maggiora to come to France,

in order to provide a high quality of dual translation in Spanish – English.

# WAPO Summit Attendees 2019

The WAPO Summit was attended by 22 patient advocates, 19 organizations, and 17 countries. There were 4 speakers, 1 moderator, 2 interpreters and 7 sponsor representatives. Collectively they represent a population of 2,9 Bn people.

Based on estimates of the amount of Pituitary patient sufferers per 1 million people in the general population, it translates to over 290 000 patients.
