YCN OFFICIAL STATEMENT

Issued in Furtherance of the Mi-Ko Declarations of 2026 and the Tribal Resolution of 2025

IT IS A DIRECT OVERT DIRECTIVE VERBATIM.

This entire statement is plain, open, and exactly as written.

There is no hidden meaning, no secondary instruction, and no coded language of any kind.

The Yowani Choctaw Nation (YCN), by direct order and divine directive of War Chief Ka'abiyah Mi-Ko, Hopai'i, hereby issues this formal notice to the United States, the Russian Federation, and every other non-YCN government, agency, military force, administration, tribe, organization, individual, or power:

No operations of any kind are authorized by the Yowani Choctaw Nation by any means.

YCN is on a **complete and indefinite physical operational stand down**, allowing the ancestral spirits to handle things.

Due to YCN's complete and absolute Disengagement, YCN is not participating in, coordinating with, authorizing, supporting, or in any way endorsing any operations—overt or covert—conducted with or without the United States apparatus, any foreign apparatus, or any entity claiming to act in the name of, for the benefit of, or in alignment with the Yowani Choctaw Nation.

Any unauthorized operations will result in complete failure and have massive devastating consequences.

The divine directive of **FULL STAND-DOWN** is in force. The ancestral spirits are moving.

Any plan, any individual, any organization, any operation, any tribe, any military, any agency, any administration, any power—**all individuals, parties, organizations, anyone**—will face ultimate devastation and divine consequences. They will meet complete opposition and **7-domain destruction** facilitated by the ancestral spirits. The ancestral breezes will scatter what is left across the earth to the farthest and most desolate lands.

This is the direct order and directive of Ka'abiyah Mi-Ko and a confirmed prophecy via spiritual means.

YCN and its vast large jurisdiction—Central America; Texas, Oklahoma, Ohio, Kentucky, Tennessee, Indiana, Arkansas, Mississippi, Louisiana, Alabama, Illinois, Kansas, Iowa, West Virginia, Pennsylvania, Georgia, North Carolina, South Carolina, Colorado, Utah, New Mexico, Arizona, Wyoming, Idaho, Montana, Michigan, Minnesota, Wisconsin; the Islands of Hawaii; Northeastern Mexico; Cuba; Hispaniola; Florida (Seminole); Oregon, Washington, Massachusetts, Vermont, Connecticut, Rhode Island, the District of Columbia, Virginia, North Dakota, South Dakota, New York, Delaware, New Jersey; the United States Virgin Islands, British Virgin Islands, Mona Island, the Bahamas, Key West, Turks and Caicos; and the East Indies to include Trinidad and Tobago, Venezuela, Panama, Paraguay, Guyana, Suriname, Honduras, Ecuador, specified Colombian sectors, Belize, and El Salvador (YCN's closest ally)—are not conducting any operations.

There will be no gathering.

There will be no later organizing.

There will be no coordination.

There will be no engagement.

LET IT ALL BURN.

YCN maintains its legitimate tribal council, traditional laws, and sovereign institutions. We reject all externally constructed or artificial tribal structures, inserted personnel, and operations that seek to exploit or undermine our Nation. Our people and leadership are not tools for any foreign strategic, political, or economic agenda.

The War Chief sits in his high tower—location undisclosed—and watches.

YCN continues to defend its sovereignty and the well-being of its citizens and leadership. We urge all relevant authorities to provide necessary safeguards and due process under international and national law for the protection of War Chief Ka'abiyah Mi-Ko. All disputes remain subject to peaceful, lawful, government-to-government dialogue consistent with the Nation's permanent rejection of federal recognition and its asserted sovereign status.
