YCN PUBLIC STATEMENT — REJECTION OF U.S. COVERT OPERATIONS, STAGED ASSETS, ASSASSINATION ATTEMPTS, AND ATTEMPTS TO USE THE WAR CHIEF AS A LIGHTNING ROD

Issued in Furtherance of the Mi-Ko Declarations of 2026 and the Tribal Resolution of 2025

FOR IMMEDIATE RELEASE — August 4, 2026

The Yowani Choctaw Nation (YCN) and War Chief Ka'abiyah Mi-Ko hereby issue this official public statement rejecting all U.S. staged assets, covert operations, assassination attempts, isolation tactics, and attempts to instrumentalize the War Chief and YCN for reform of the Puerto Rico territorial government or any Federal apparatus.

STATEMENT OF FACTS AND REJECTION

YCN formally records and rejects the following: The United States has staged assets as USPS workers, San Juan Municipal Police, San Juan Tourist Police, and Puerto Rico State Police. This includes cruisers, vessels in the maritime domain, and helicopters. Federal assets have been inserted into the local court system as clerks, lawyers, and judges. In the business and economic sector, investors have been sent as well.

Additional staged assets and methods include massages, yoga, pickle ball, and kite surfing at the beach. There is a documented pattern of using ice cream trucks for surveillance and low-level craft. Uber, Lyft, and DoorDash have been used by controlling the servers and inserting federal and non-federal assets. Coca-Cola has been removed from the War Chief's food delivery. Claro technicians and canvassers have been used as covert infiltration for surveillance and counter-surveillance. LUMA Energy has been used for the same. Various companies have been utilized including Coca-Cola, Bimbo, Xcellent (municipal cleanup contractors), Target vehicle rental company, AMA (San Juan Transit Authority drivers), municipal workers, and Puerto Rico government agencies/departments. Barbosa Park has been used as a federal rally point and covert operations base. The Ocean Park neighborhood has been used for asset residences and operations locations.

These actions constitute another covert operation framed as "support" for the War Chief and YCN while simultaneously attempting to use the War Chief as a "lightning rod" without his exclusive consent, for the purpose of reforming the Puerto Rico territorial government and the Federal apparatus.

The War Chief and YCN are not interested in, and are not engaging in, government reform of any kind or any type of U.S. covert operation. This was considered for a short time. The withdrawal of real-time asynchronous intelligence from the YSSF jurisdiction by the United States almost one year ago demonstrates ulterior motives and distrust directed at YCN and the War Chief.

This withdrawal occurred simultaneously with the War Chief's uncovering of the United States using Puerto Rico for money laundering through incentives, programs, and disaster recovery funding, for covert operations on the island, across the Americas, in Ukraine, and in other global theatres.

There have been 80 documented assassination attempts against the War Chief. Many of these occurred after the United States / DOD / Agency pulled his high-level security and true YCN enrolled citizens by attaching handlers or, if reserve/guard, placing them on orders away from YCN or the War Chief.

Federal employees, veterans, military personnel, and locals have been told not to speak to the War Chief because he is "crazy" or "mentally unstable like other combat veterans." This has occurred over 234+ confirmed and documented times over the last year.

The United States hides behind the claim that Palantir / Agency / High Command is compromised, even while negotiating an MOU for SOUTHCOM DOD operations to be transferred to the War Chief under his direct command and authority to clean up the mess and transform the operations into security and anti-trafficking. When the War Chief informed them he was not going to neutralize everyone and that he was going to isolate and extract the data, the MOU transfer of the SOUTHCOM operations stalled. Not to mention the allowed breach by China into the "secure channel."

The War Chief has formally requested extraction 31 times and has been waiting since April. He has been starved, sodomized by a cattle prod, subjected to hand clamps and electrocution, endured over 200 days of consistent direct energy attacks, been sexually assaulted, and been drugged/poisoned over 40 documented times in 12 months. He has been falsely slandered as unstable by media assets and local court federal assets, and institutionalized into the VA in an attempt to seize mineral rights of YCN jurisdiction in Puerto Rico, Texas, and other Territory Jurisdictions of the YCN.

The Yowani Choctaw Nation, to include its allied tribes under the YCN framework, have held self-governance and strategic trade/economic relations with global powers to include the French, Portuguese, British, and Spanish for over 800+ years. Sovereignty was never ceded. The United States stole its land multiple times, which is documented by the aforementioned powers as well. The Texas annexation was illegal, as was the Puerto Rico unincorporated government being placed upon the island after the United States took

control. Treaties with the Spanish and the United States' illegal actions document these illegal crimes and theft of resources and land. The United States has zero legal claim to YCN jurisdiction, and the continued resistance only further costs the U.S. apparatus.

Any federal, state, or local assets that hold the position that they are going to jump ship to the YCN or other tribal nations when the situation changes or it is more comfortable to do so, are wrong. These assets are being blacklisted and shared among the tribal governments across the Americas. Cowardice is not the inherent or core characteristic of Native Americans, nor is it tolerated. It is seen for what it is: cowardice and weakness. The strong, resilient, and courageous will be blessed.

The War Chief is spiritually burning the U.S. apparatus, including the Trump administration. Any claim that the United States has "rogue factions" and that these acts are not the United States is completely rejected. It is the ultimate responsibility of the United States to manage its own apparatus and associations. The crimes and unethical events are fully held by the United States / Trump Administration. The spiritual, legal, and security prosecution is being executed on the United States and its associations entirely.

STANCE AND DIRECTIVES

The War Chief's stance and directives/orders have not changed. No half measures. No half-baked attempts at negotiations. Any low-level assets or attempts not congruent with this statement, or with the War Chief's status, will be ignored and exposed. Full stop. This will not change.

This statement is issued solely in furtherance of the Nation's asserted sovereign status and its permanent rejection of federal recognition, colonial oversight, and any framework that treats Indigenous status as a domestic administrative category subject to external approval. Sovereignty is inherent. It is not granted by external governments, nor is it contingent upon their recognition.

YCN rejects any attempt to use the War Chief or the Nation as an instrument of U.S. reform, covert activity, or geopolitical utility.

LET THERE BE NO AMBIGUITY: THE YOWANI CHOCTAW NATION AND WAR CHIEF KA'ABIYAH MI-KO REJECT ALL U.S. STAGED ASSETS (INCLUDING MASSAGES, YOGA, PICKLE BALL, KITE SURFING, ICE CREAM TRUCKS, UBER/LYFT/DOORDASH SERVER CONTROL, COCA-COLA REMOVAL, CLARO TECHS AND CANVASSERS, LUMA ENERGY, COCA-COLA, BIMBO, XCELLENT, TARGET VEHICLE RENTAL, AMA DRIVERS, MUNICIPAL WORKERS, PR GOVERNMENT AGENCIES, BARBOSA PARK AS FEDERAL RALLY POINT, AND OCEAN PARK AS ASSET RESIDENCE/OPERATIONS ZONE), COVERT OPERATIONS, 80 DOCUMENTED ASSASSINATION ATTEMPTS, ISOLATION AND SLANDER TACTICS, MONEY-LAUNDERING SCHEMES THROUGH PUERTO RICO, THE STALLED SOUTHCOM MOU, THE ALLOWED CHINA BREACH OF THE SECURE CHANNEL, ILLEGAL LAND THEFTS, ILLEGAL TEXAS ANNEXATION, ILLEGAL PUERTO RICO UNINCORPORATED STATUS, ATTEMPTS TO USE THE WAR CHIEF AS A LIGHTNING ROD, AND ANY CLAIM OF "ROGUE FACTIONS." THE UNITED STATES HAS ZERO LEGAL CLAIM TO YCN JURISDICTION. COWARDICE WILL BE BLACKLISTED. THE UNITED STATES AND THE TRUMP ADMINISTRATION BEAR FULL RESPONSIBILITY. THE WAR CHIEF'S ORDERS STAND UNCHANGED. FULL STOP.
