# Dog Boarding Agreement

THIS DOG BOARDING AGREEMENT (this "Agreement") is made and entered into by and between BONZAI'S BARK, LLC, a D.B.A in California State, and the person identified as the "Dog Parent" below. This Agreement applies to all visits & rates at BONZAI'S BARK LLC.

## Services

BONZAI'S BARK LLC. provides dog boarding and daycare services. Dog Parent hereby engages BONZAI'S BARK LLC. to provide the services for his or her dog(s) as set forth on the website, the information sheet provided to the Dog Parent, the terms and conditions set forth in this Agreement and in any supplemental dog information or reservation form, emails & texts provided in connection with this Agreement by BONZAI'S BARK LLC.

## Payment

Dog Parent agrees to pay all current rates & fees (posted) for boarding, daycare, veterinary care or other services owed on the day of pick up. Prices are subject to change without notice and seasonal rates do apply. Client can pay via Check, Cash, Zelle, or Venmo.

## Cancellation

If you need to cancel your reservation, please do so at least (1) week prior to your arrival date. BONZAI'S BARK LLC. reserves the right to charge a late cancellation fee of \$50.

**STRICT Drop Off & Pick Up:** By appointment only. Client agrees to follow drop off and pick up per rules provided. Overnight pick up is the same time as drop off, unless otherwise communicated. If late, an extended daycare fee may be added to your bill. No unauthorized times are allowed if not clearly communicated. All rules & policies provided by BonZai's Bark, must be followed to best & safest possibility & responsibility of dog owner.

## Health and Vaccinations

Dog Parent represents to BONZAI'S BARK LLC. that, to Dog Parent's knowledge, your dog has had solid stools and not been exposed to any contagious diseases within a thirty-day period prior to check-in. BONZAI'S BARK LLC. reserves the right to refuse to accept a dog at check-in for any reason, including without limit, if it appears to us the dog is sick, injured, in pain, or that its behavior could jeopardize the health or safety of other dogs or our staff. Also we reserve the right to serve only small dog breeds up to 20lbs.

Dog Parent acknowledges dog is current on all vaccinations required by BONZAI'S BARK LLC. Dog Parent agrees to provide documents confirming such vaccinations as requested by BONZAI'S BARK LLC, and shall provide proof of vaccinations prior to any entry into BONZAI'S BARK LLC. facilities. Dog Parent understands all dogs at BONZAI'S BARK LLC. are fully vaccinated. However, it is still possible for your dog to become ill, even if vaccinated in any social environment. Also dogs will mingle with out of state pets who are vaccinated, but may bring something foreign to the desert. Dog Parent understands that this is not due to any circumstance or condition at BONZAI'S BARK LLC. and agrees to not hold BONZAI'S BARK LLC. liable in the event your dog becomes ill or dies during or after his/her stay. If at any time your dog is found to have fleas or ticks the appropriate flea or tick removal treatment will be necessary before dog can come back for next visit.

## Emergency Medical Treatment

Dog Parent acknowledges, in the unlikely event your dog becomes ill, injured, passes, or if your dog has a pre-existing condition which is aggravated by its stay, and requires professional attention, we will attempt to notify you and your Emergency Contact at the phone numbers you provided. BONZAI'S BARK LLC., at its sole discretion, may engage the services of a 24-hour emergency veterinary clinic or a veterinarian of our choice and/or administer medicine or give other necessary attention to your dog, and you authorize us to provide any such service at your additional expense. In cases we believe to be critical, we may take your dog to the veterinarian first before trying to contact you. If you refuse medical treatment for your dog, BONZAI'S BARK LLC., at its sole discretion, may engage the services of a veterinarian and/or administer medicine to make your dog as comfortable as possible until picked up by you or your Emergency Contact, and you authorize us to provide any such service at your additional expense. If we cannot reach you or your Emergency Contact, we will make healthcare decisions for your dog based on the recommendations of available professionals.

In the unfortunate event that your dog passes away at BONZAI'S BARK LLC., your dog will be taken to a vet clinic, and held per their rules & rates. If you would not like us to notify you while you are away or you would like us to make other arrangements, please let us know in writing so that we may best know how to accommodate you and your pet.

### **Emergency or Natural Disaster**

In an emergency or natural disaster, every effort will be made to contact you and your Emergency Contact to retrieve your dog. You agree that BONZAI'S BARK LLC., at its sole discretion, is authorized to transport, and/or to make temporary alternative arrangements to house and care for your dog until you or your Emergency Contact can retrieve pet. You understand it may not always be possible to safely evacuate your dog.

### **Group Activity**

Dog Parent understands that while your dog is staying at BONZAI'S BARK LLC., he or she will come into contact with other dogs. Every effort will be made to ensure the safety of our guests. Dog Parent acknowledges that, in the unlikely event your dog is injured by another dog, you release BONZAI'S BARK LLC. from any liability for such injury or death. If your dog injures another dog, you will be solely responsible for any injury to the other dog(s) as well as your own dog, and you release BONZAI'S BARK LLC. from any liability for such injury.

### **Dog Behavior**

Dog Parent agrees that if dog becomes aggressive, destructive or disruptive, or acts in any manner that puts BONZAI'S BARK LLC. , guests, and employees in any danger, we will attempt to notify you or your Emergency Contact to make other arrangements for your dog. In the event that you or your Emergency Contact are unavailable, BONZAI'S BARK LLC, at its sole discretion, may make other arrangements at an alternative boarding facility chosen by BONZAI'S BARK LLC. You will be billed and responsible for any fees incurred at both BONZAI'S BARK LLC. and the alternative dog boarding facility.

### **Photos and Video Release**

Dog Parent agrees to allow BONZAI'S BARK LLC. to use your dog's name and any images or likeness of his or her dog taken while the dog is staying at BONZAI'S BARK LLC., in any form or format, for use, at any time, in any social media, marketing, or advertising.

### **Personal Property**

Dog Parent agrees that BONZAI'S BARK LLC. and our representatives and employees will not be liable or responsible for any lost, stolen or damaged personal property belonging either to the Dog Parent or the dog. Dog Parent also understands and agrees that dogs should have a collar with tags, leash, and harness for their dogs in case of emergency. If dog is destructive, owner will be responsible for excessive damages.

### **Abandonment**

Dog Parent understands and agrees that if his or her dog is not picked up within fifteen (15) calendar days after the scheduled pick up date, or Dog Parent refuses to pay agreed upon charges, the dog shall be deemed to be abandoned (as defined in RCW 16.54.010). Dog Parent agrees that you have read this entire Agreement, you have had the opportunity to discuss it with us to your satisfaction, and you agree to its terms.
