The client, desiring to use M&M services agrees that all reports will be submitted and received subject to the following conditions:

- 1) All reports will be kept strictly confidential: except as required by law, no information from reports will be revealed to any person except a person whose duty requires him to pass the information in relation to which the report was ordered. No information will be requested for the use of any other company or person other than the individual signed below, or that individual's authorized agent. Requests for report information from the person reported on will be referred to the authorized client who will provide the report for disclosure as provided under the Fair Credit Reporting Act or other applicable laws. Each authorized user of report information will receive and maintain on record for a period of at least two years a signed release from each applicant authorizing M&M Management Plus, Inc. to supply information concerning applicant's background.
- 2) The Client certifies that these reports will be ordered only when intended to be used as a factor in establishing an individual's eligibility for new or continued credit, in connection with a credit transaction involving the consumer on whom the information is to be furnished and involving extension of credit, collection of an account, insurance, employment purposes, or otherwise in connection with legitimate business need or a business transaction, only consented to by the individual in writing. M&M cannot provide credit reports for personal use to client.
- 3) M&M cannot be an insurer of the accuracy of the public records. The undersigned understands and agrees that the accuracy of any information furnished is not guaranteed by M&M and the undersigned releases M&M and M&M affiliated companies, their officers agents and employees, from any and all liability including without limitation, liability or damage from any negligence in connection with the preparation of such reports and from any loss or expense suffered by the undersigned resulting directly or indirectly from M&M reports or those M&M affiliated companies.
- 4) In no event shall M&M have any responsibility or liability to the Client whatsoever for any failure or delay in performance by M&M which results from or is due to, directly or indirectly and in whole or part, any cause or circumstances beyond the reasonable control of M&M. Every effort to complete a successful search will be made. However, "No File Found" reports are billable.
- 5) The client understands and agrees that this letter constitutes all conditions of service and of reporting, present and future, and applies to all reports made by M&M and M&M affiliated companies to Client at the Home Office or to any client branches or service offices. No changes in these conditions may be made by consent in writing of an officer of M&M or any successor corporation or entity.

- 6) The provisions of this agreement relating to indemnification and confidential information shall survive any expiration or termination of this agreement.
- 7) Payment for all dues and services are to be paid prior to the services being performed by cashiers check or money order. If an account is established, all payments must be made within ten (10) days of the date listed on the invoice. Any payments not received within 30 days will be assessed a Late Payment Charge of \$15.00. If client defaults on payment, client guarantees and agrees to pay for all costs of collection, including reasonable attorney's fees.
