Individual Release of Liability Form

Please read before signing, as this constitutes an agreement as a volunteer and the understanding of your working relationship with Faith Responders Disaster Relief and Recovery Agency, a ministry partner of the Florida Conference of the GMC.

- I have chosen to travel to the designated disaster response or recovery area to perform cleanup, response or recovery construction work designed to assist homeowners impacted by a disaster.

- I acknowledge and agree that, in the event of a local disaster, any actions I take while representing or operating under the name of **Faith Responders** shall bind me, and any individual, organization, or church I am affiliated with for the purposes of such service, to full compliance with all safety protocols, procedures, rules, and regulations established by Faith Responders.
- I further acknowledge and agree that **Faith Responders must be notified of, and made aware of, any actions, engagement, or response activities** undertaken by me or on my behalf while operating under its name or authority. **Initial:** _____
- I understand that this work entails a **risk of physical injury and often involves hard physical labor**, heavy lifting, and other strenuous activity, and that some activities may take place on or while using equipment and/or on ladders. I certify that I am in good health and physically able to perform this work. I also certify that I understand and agree to follow the safety protocols for onsite work and in using the equipment needed for this work. **Initial:** _____
- In the event that I require accommodations, I acknowledge and agree that **Faith Responders, the Global Methodist Church, the host site, and any associated church are not responsible or liable for my personal belongings or property**, nor are they obligated to provide secure storage, lock-up facilities, or security for any items I bring. - I further acknowledge that I am required to **comply with all rules, policies, and regulations** governing the accommodations in effect at the time of my stay. - I grant permission to Faith Responders, its representatives, staff and partnering organizations to photograph, film or otherwise record my image, likeness, voice or statements during any Faith Responders events, outreach, deployment, training or activity. I authorize Faith Responders to use these photos, videos and recordings for ministry purposes including but not limited to social media, Facebook, email, fundraising, volunteer recruitment, website or printed materials. I understand these images may be used without compensation and may be edited, modified, or combined with other media. **Initial:** _____
