Mayor Announcements:

- 1.) Robin Summerfield, the Western Maryland Representative for District 6 for Maryland Senate, contacted Mayor Reckart to come as the representative for the Mayors of Garrett County at a Political Event that is being held in Annapolis on April 26th.
- 2.) WATER UPDATE FROM PUBLIC UTILITIES: Received an email as we were sitting down for the email from Public Utilities that stated the following: Majority of equipment is on site at the water system. The installation of the equipment they have on site has begun. Public Utilities is currently working on testing and sampling right now. They are hoping to have everything up, running, & operational by March 28th.

Grants:

<u>USDA – Dump truck – Reimbursement has been received.</u>

<u>CDBG – Blighted Property</u> – Craig Ingram's Office is working on finalizing the sell of the property from Bernadine to the Town. The Town got permission to advertise for the demolition of the building. However, the Fire Department has expressed interest in using the building as a "Training." If this is the route we take, we would only be responsible for the clean-up/removal of the debris.

<u>Project Open Space</u> – Park Bathrooms – Dates are being set for Prebid meeting & for the advertising. We also need to check on specs for the bathroom. (Toilets, Sinks, Urinals, Changing Tables)

<u>Thriving Communities</u> – The RCAP solutions team will be visiting Kitzmiller the week of April 28th. Through this grant process, we also found out that State Parks (Ex: Wolf Den) are not allowed to advertise for businesses. They are however allowed to advertise for other State Parks & Municipalities. If everyone remembers, Karen Myers from the GC Historical Society mentioned different grants for municipalities to use for advertising. We would be able to include different businesses in the town in our advertising brochures.

Remaining Park Funds - Still waiting on Payment.

Brownfield Grant - Siera Wigfield, Beccie, & Code Enforcement Officer are working on "mapping." Old Business:
