# Mayor & Town Council Monthly Public Meeting Minutes

The meeting was called to order at 7:01 PM by Mayor Reckart. Opening Prayer was led by Dale Lipscomb, followed by the pledge of Allegiance.

Councilmember Brady motioned the approval of the Meeting Minutes from Monday, August 26th, 2024. Councilmember Hawk seconded the motion. 4-0. Motion carried.

## Recognized Guests:

- Dale Lipscomb, Museum Coordinator Dale asked if it would be possible to get a plaque for all of the Vietnam Veterans from in and around Kitzmiller. Suggested making a Facebook Post & publishing it in the next Newsletter.
- Justin Nesselrodt, Resident Asked if the town could double check with the county to make sure they will be fixing the roads where they have been flushing the fire hydrants because it seems as though it is making the roads deteriorate quicker. Justin also asked if Kenny could get the property between the Fire Department and the Floodwall weedeated. Justin also suggested that the Town get No Smoking signs for the new dump truck. The storm drain on E. Main street across from Tim Wilt's house, seems to be falling in again and suggested replacing the box underneath. Councilmember Hawk thinks that he may have one from the last project that he did for the town.

Also in Attendance with nothing to add is Missi Nesselrodt, Sharon Paugh, Rhonda Sisler, & Rita Lambka.

#### **Grants:**

<u>USDA – Dump truck – Modifications that are being completed by J&J are scheduled to be</u> completed around the first/second week of October. The truck will then be returned to Diehl's Ford for them to complete the remaining modifications. The truck is expected to be completed by the end of October!

<u>Community Parks & Playgrounds – Park Bathrooms – Working on a way to make the footprint</u> of the new restrooms big enough to accommodate an electrical closet and also have enough room so that they are ADA compliant.

## Project Open Space -

- 1. Portable Stage It was voted upon last meeting to order the "projector" if it was rear displaying. It turns out that what was thought to be the "projector" on the estimate was actually LED Display Panels that will be hung on the rear of the stage. The order was placed with Sweetwater and has since been delivered. Beccie and Kenny are planning a day to set everything up to make sure it is all there and finalize this grant.
- 2. Electrical Upgrades in Park Electrical upgrades have been completed on the pond end of the park. The rest of this project is to be completed once the new bathrooms have been installed.

CDBG -

1. Blighted Property — Beccie had a meeting with the CDBG advisors that informed her that she did not have to advertise for the Environmental Survey, that letters need to be sent to different organizations/individuals that can complete the survey as the funds are already in place for the survey to be completed. Letters have been sent to those around the area that do an "Environmental Survey" for the property. In the meantime, Beccie is working with the circuit rider to complete a checklist that needs to be completed before demolition. This process can take anywhere from 8 to 12 weeks. An advertisement has been placed to be included in this week's Republican for the release of funds, so the town can officially begin the purchase of the building.

#### Old Business:

<u>Update on Security Systems</u> – Installation of security system is complete. We are currently working out all of the little things that need to be completed.

Streetlight at Water Plant: They are coming to assess the location on Thursday of this week and will contact the Town Hall with what they believe would be best. The original person that Beccie spoke to put in a repair order, rather than an installation order. Beccie was able to speak to Potomac Edison today to get that corrected and had the installation request sent. They will be getting back to her.

Race/Flood Gate: Beccie's meeting with the Director went really well. They were able to contact MULTIPLE State and Local Agencies that will be able to help us get the funding that we need to get the gate fixed. Beccie was given a list of four approved contractors to do the work and contacted each of them. She was then able to meet with 3 of the contractors, all of whom seem to be thinking that the issue resides inside of the stem base (the part above ground). She did receive estimates, and they are included to vote upon under new business.

Clutter on Kitzmiller Addition Alley: Beccie was able to speak with the owner of the lot along the back side of the alley. The owner asked Beccie to turn it over to code enforcement. Letters have been sent to the residents that surround the owner's property from the Town. They have 14 days to start cleanup, then Code-Enforcement will be stepping in.

Intake Hose for Leafvac: The new parts for the leafvac were ordered and received. Kenny is planning to get it repaired this week. He and Beccie were looking at the schedule for leaf pick up and are looking at the second or third full week in October depending on leaf fall.

Savvy Citizen: Beccie found a Government Program that may work, that does not cost anything. It will be mass texting if this is something we would consider. She has a meeting later this week to get more information.

Dog on Main Street: Beccie was able to contact the owners of the dog on Main Street. They sent a letter to the Mayor and Town Council and asked that it be discussed in the executive session.

Grill in Park: The new grill was ordered and received. It will be installed in the spring.

Hall Divider for Thrift Shop: Beccie contacted the Facilities Director to see if this is something that can be done. He gave the official "Okay" for the project to be completed.

Storm Drains on E. Main: Kenny was able to clean out all of the storm drains along E. Main Street and straighten up the grates that were falling in. Kenny is also working on cleaning out all of the ditches throughout the town.


