#### New Business:

Next year we may be able to get some bigger fireworks, Josh Hook suggested talking to the County Commissioners they may have some more money by then to give away for events.

Town of Kitzmiller: Various Issues

The following is a summary of issues you and I visited today, please review and let me know if there are any corrections required.

Item No.1: Church and Third Street Drainage Issue.

Proposed repair is to install a drop inlet at low point on east side of Third street and connect to existing stormwater inlet at the corner of Third and Church. Request that the Town have the utilities marked in this area and notify the county when marked so county can survey locations and grades so a plan can be created for construction. Expect completion in 30 days from notification that utilities have been marked.

Item No. 2: Union Street Bridge.

Sidewalk failure on the bridge necessitated the placement of concrete barriers to guide traffic away from failure area. Due to the span of the bridge the County can place the bridge on the County's bridge inspection inventory. The county will have the bridge inspected and rated and repair recommendations with cost estimate report prepared. A copy will be provided to the Town. County's current bridge inspection cycle just began August 1st, inspection will be completed within next 60-75 days as this bridge will be added to current cycle. Report will follow. Any immediate repairs that effect vehicular traffic are reported within 24 hours of inspection.

Item No. 3: Oak Street drainage and roadway improvement (widening).

This will require survey work and watershed analysis for inlet and pipe sizing. County will put this on our fall field work schedule when the leaves and vegetation have fallen. Based upon the field survey a scope of work will be developed along with an estimate. Information will be sent to the town. Work or funding is undetermined currently.

Item No. 4: Alley R - drainage issues.

This will be included in the Oak Street field work.

Item No.5: Retaining wall on south side of Alley H.

Site will be inspected in the fall when a better view of the extent and adjacent areas are more visible. A scope of work will be produced with repair recommendation.

Item No. 6: Spring street Retaining wall repair.

To be addressed in same manner as Item No. 5

- Garrett County Commissioners POS Money will be used to get the pond in the park fixed. 4 more picnic tables & Benches. We received a letter from POS that we were unofficially approved for the funding. Waiting on the official Approvement.
- Well Connected Communities Moved the play equipment from behind the school to the front of the school to where it would be utilized more. They received the new swings. There will also be 2 or 3 octagon tables installed. The new Welcome to Kitzmiller sign is to be installed within the next two weeks. Julie Wagner, from Julie's Greenhouse, came down to give an estimate on what the price would be to put in new plants/trees etc. They will also be repainting some of the equipment as well.

#### Old Business-

- Park Lights They have been called on 3 times, they haven't called back.
- Jenkins/Gank Residence Cleaned up.
- Hook at Pavilion It has been installed in the center of the pavilion.
- Code Enforcement Emailed Jarrett about "zoning" and never got a response back. Beccie will follow up with him.
- Garrett County Engineer Currently working on the blueprint plan for drainage to be put in between 107 and 105 Third Street.
- Paving Have to wait on spring. Especially having to repave where the gas lines were replaced.
   The County is too behind to get everyone done this year and will have to follow-up again next spring.
- Alley at Michael Hechmer's House Closing of the alley with Jersey Barriers has been approved.
- Personnel Policy Red Lined Copy has been received, it will be corrected and discussed at the next meeting.
- New Flooring in Office Happening soon.
- Thrift Store Jamie Rodeheaver, the fire Marshall, has been unreachable. \*He is retiring. \*
  There will be someone new to replace him. However, the electric, new lighted exit signs & an architect will have to draw a new floor plan for upstairs with accurate scaled drawing. Nancy

requested the rooms upstairs that are closest to the library. Fire extinguishers at school need to be updated, will have to call the county.

#### **New Business-**

- Ralph and Barbara Lucas Dumpster Diane Nye Paugh motioned to replace the dumpster. To
  first check with the insurance company to see if it would be covered. If not, then to pay \$75
  towards a replacement. Theresa Second, 3-0.
- ARP Money The money is still being fine-printed with what can be done with it. However, organizations such as the Fire Department, Lions Club, & After School are all liable non-profit organizations that could benefit from this funding. We will have until January of 2026 to have the money spent to their guidelines. Cindy Stone is the one in charge of these funds. Those organizations will have to fill out an application to receive the funds.
- Play Equipment at School Checking to see what can be fixed or if it can even be fixed. Siera Wigfield, has developed a survey "Kitzmiller Rec Survey" to help us potentially get a grant to replace the equipment. The survey will serve as the "paper trail." The life expectancy of play equipment is roughly 25-30 years. The one at the school right now is nearing 25 years. We need to keep this in mind when we apply for grant money.
- New Shop & Office Doors the doors to the office and the Shop are in terrible shape and need
  to be replaced. Sharon Motioned for the doors to be replaced, Theresa second, 3-0.
- 279 West Main Street Letter was sent on Friday, September 24, 2021.
- Fall Social Diane made a motion to cancel the fall social and use any funds allotted for the Social, for Autumn Glory with Kitzmiller. Sharon Second, 3-0.
- Maintenance Position Advertise in the Republican by October 7<sup>th</sup>, 2021. Needs to be sent to the paper by October 4<sup>th</sup>. The second week would be October 14<sup>th</sup>. Applications will be due by October 22<sup>nd</sup>. They will be reviewed at the next meeting in executive session, and interviews will be set up to begin on the 27<sup>th</sup> at 4PM.
