ORDINANCE NO. 2020-01

NUISANCE ORDINANCE AMENDMENT

AN AMENDMENT TO AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF KITZMILLER PROHIBITING THE CREATION OR MAINTENANCE OF CONDITIONS, ACTIONS, OR ACTIVITIES WHICH CONSTITUTE A NUISANCE WITHIN THE TOWN

WHEREAS, the Mayor and Town Council of Kitzmiller is authorized by Section 5-207 (Legislative Authority) of the Maryland Annotated Code and by the Kitzmiller Town Charter to enact ordinances to protect the health, safety and welfare of residents of and visitors to Kitzmiller;

WHEREAS, on June 25, 2007, the Mayor and Town Council of Kitzmiller adopted a Nuisance ordinance to prohibit the creation or maintenance of such conditions, actions or activities which constitute a nuisance within the Town and which thereby negatively impact the residents and visitors to the Town as well as properties and property values;

WHEREAS, the Mayor and Town Council of Kitzmiller have received complaints regarding animals (including livestock) within the Town of Kitzmiller;

WHEREAS, the Mayor and Town Council of Kitzmiller find it necessary to amend the provisions of the Nuisance Ordinance in order to more effectively regulate the existence of animals (including livestock) within the Town of Kitzmiller;

WHEREAS, Article Two of the Ordinance, "Nuisances Enumerated", Section G., currently states:

G. The keeping of any animal or bird, which, by causing frequent or long-continued noise, shall disturb the comfort or repose of any persons in the vicinity.

NOW, THEREFORE, BE IT ORDAINED AND RESOLVED, the following amended Article Two of the Ordinance, "Nuisances Enumerated", section G.(1), is hereby enacted:

- G. The keeping of any animal or bird, which, by causing frequent or long-continued noise, shall disturb the comfort or repose of any persons in the vicinity.
- (1) Livestock including, but not limited to; cattle, sheep, goats, horses, swine, emus, and alpacas, shall explicitly be prohibited from being kept in the Town due to their propensity to create offensive odors, excessive noise, and unsanitary conditions

BE IT FURTHER RESOLVED, this ordinance shall be duly advertised in accordance with the policy for the Adoption of Ordinances by the Mayor and Town Council of Kitzmiller. A public hearing on this amendment to the Nuisance Ordinance shall be held on the **24**th **day of February**, **2020** at **6:30pm** at the Kitzmiller Town Hall, located at 104 W. Center Street, Kitzmiller, Maryland 21538.

SECOND READING AND ADOPTION this 24th day of February, 2020.

AND IT BE FURTHER RESOLVED, this ordinance shall be effective as of the 30th day of March, 2020.
