11:15 am Lunch on your own and shopping at Walnut Creek Cheese Café.


12:30 pm Depart for guided tour of "Behalt" Amish and Mennonite Heritage Center. "Behalt" is a stunning 10-foot by 265-foot circular mural located at the center, illustrating the rich history of the Amish and Mennonite communities. This mural is one of only four cycloramas in North America and is the only one painted by a single artist, Heinz Gaugel. In addition to the mural, visitors can explore various displays, including a Conestoga wagon and a one-room schoolhouse, which further illustrate the daily lives and traditions of the Amish and Mennonite peoples.

Breakfast included at the hotel.


10:00 am Depart for Dutch Valley for a little shopping lunch and performance.

- List of passenger names will be included in final billing.
- **Cancellation Policy - Deposit fully refundable up to 30 days prior to trip departure; 30-15 days prior to departure – 50% of your trip cost is non-refundable; 14 days prior to departure – 100% of trip cost is non-refundable. If replacement is found, you will be refunded all your money except for a \$25.00 per person cancellation fee.**
