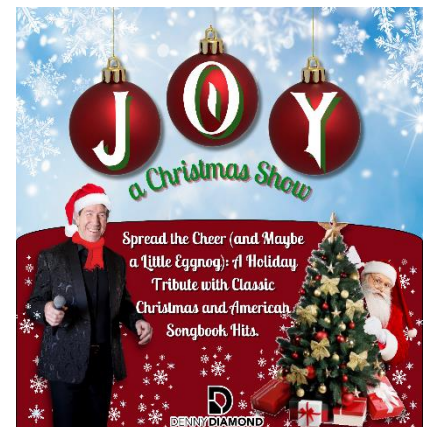


Holly Jolly Christmas & Lights of Oglebay

Thursday – Saturday, November 12-14, 2026

Thursday, November 12th

- 7:20 – 8:00 am Pickups will be in Celina, St Marys, and Wapakoneta. Exact pickup times will be determined approximately 30 days prior to trip departure.
- 11:15 am Arrive at Reeves Victorian Mansion for included lunch and tour. This opulent mansion, the former residence of prominent Dover industrialist, Jeremiah E. Reeves, has been carefully restored to its original turn-of-the-century splendor and features the unique treasures of the original furniture and antiques that were the property of Mr. and Mrs. Jeremiah E. Reeves, arranged as they would have been 100 years ago. The Carriage House Museum, located behind the home, keeps its original purpose by housing an interesting collection of vehicles including the family's original 1892 carriage, along with the family sleigh, a rare 1922 electric car, and a restored doctor's buggy. Christmas is a special time at the Reeves Victorian Home and Carriage House Museum. During the holidays all seventeen rooms of the mansion are beautifully decorated. Guided tours are led by a knowledgeable tour guide and will include an introduction to the Home and Carriage House, and information and anecdotes about the Reeves family.
- 2:15 pm Depart for Tis the Season Christmas Shoppe, Ohio's largest year-round Christmas store, is 20,000 square feet of Christmas wonderland! Located in the heart of Amish Country, this unique store is located in an 80' round building that adds to the charm of this one-of-a-kind shop. You will see thousands of ornaments, garlands, tree toppers, and more than 100 varieties of lights and over 70 decorated trees in themes from hunting and fishing to Victorian and traditional.
- 3:45 pm Depart for hotel in Dover OH and check in. A little time to freshen up
- 5:30 pm Depart for Amish Door Restaurant for a sit-down plated dinner followed by the "JOY" show with Denny Diamond. Denny will delight you with his smooth yet powerful vocals coving holiday songs from America's songbook featuring covers from Neil Diamond, Frank Sinatra, Bing Crosby and more

- Balance due 9/12/26. Additional trip information and billing will be sent at that time.
- List of passenger names will be included in final billing.
- **Cancellation Policy - Deposit fully refundable up to 30 days prior to trip departure; 30-15 days prior to departure– 50% of your trip cost is non-refundable; 14 days prior to departure – 100% of trip cost is non-refundable. If replacement is found, you will be refunded all your money except for a \$25.00 per person cancellation fee.**
- If less than 30 passengers sign up for this trip, MCCOA reserves the right to cancel the trip or make any necessary changes to conduct the trip with a reduced number of passengers.
- Parking will be available in the parking lots at all locations. **Please plan to arrive approximately 15 minutes prior to the scheduled departure time.**

- You may bring snacks and drinks on the bus.
