- 8:35 am Depart west end of Chief's Supermarket Parking Lot, 221 Summit St, Celina, OH - Near the Celina Water Tower
- 8:55 am Pickup and depart St Marys Plaza between Marathon and McDonalds.
- 9:15 am Pickup and depart Bob Evans in Wapakoneta (Park behind building between Bob Evans and the hotel.)
- 11:30 am Arrive at Great American Ball Park. **You can bring your own food and non-alcoholic drinks (small soft side coolers, no glass or cans) into the ballpark. Ball Park vendors only accept credit / debit cards – no cash. No backpacks**
- \$142 - Infield Box Seat in the Shade** and lunch on your own at the ballpark.
- \$191 - Bally Sports Club Seat** - These seats include access to the all-inclusive Bally Sports Club offering a wide selection of food items as well as unlimited water and soft drinks in a climate-controlled setting. Additionally, fans can purchase alcoholic beverages from bars located in the Club. Guests can access the Bally Sports Club by taking the elevators or stairs, near sections 126 and 135, to Club Level.

- 3:45 pm Approximate time to depart the ballpark. We will not be stopping for dinner so you may want to bring snacks with you.
- 6:15 pm Approximate time to return to Wapakoneta.

- Deposit required within 14 days of making your reservation to confirm your reservation.
- Balance due 4/14/26. Additional trip information and billing will be sent prior to that date.
- List of passenger names will be included in final itinerary.
- **Cancellation Policy - Deposit fully refundable up to 30 days prior to trip departure; 30-14 days prior to departure– 50% of your trip cost is non-refundable; 14 days prior to departure – 100% of trip cost is non-refundable. If replacement is found, you will be refunded all your money except for a \$25.00 per person cancellation fee.**
- If less than 30 passengers sign up for this trip, MCCOA reserves the right to cancel the trip or make any necessary changes to conduct the trip with a reduced number of passengers.
- Parking will be available in the parking lots at all locations. **Please plan to arrive approximately 15 minutes prior to the scheduled departure time.**
- The dress for attractions is casual.
- You can bring snacks and drinks on the bus.
