- 8:35 am Depart west end of Chief's Supermarket Parking Lot, 221 Summit St, Celina, OH - Near the Celina Water Tower.
- 8:55 am Pickup and depart St Marys Plaza between Marathon and McDonalds.
- 9:15 am Pickup and depart Bob Evans in Wapakoneta (Park behind building between Bob Evans and the hotel.)
- 11:30 am Arrive at Great American Ball Park. **You can bring your own food and non-alcoholic drinks (small soft side coolers, no glass or cans) into the ballpark. Ball Park vendors only accept credit / debit cards – no cash. No backpacks.**
- Infield Box Seat in the Shade** and lunch on your own at the ballpark.
- Bally Sports Club Seat** - These seats include access to the all-inclusive Bally Sports Club offering a wide selection of food items as well as unlimited water and soft drinks in a climate-controlled setting. - List of passenger names will be included in final itinerary.
