- List of passenger names will be included in the final billing.
- **Cancellation Policy - Deposit fully refundable up to 30 days prior to trip departure; 30-14 days prior to departure – 50% of your trip cost is non-refundable; 14 days prior to departure – 100% of trip cost is non-refundable. If a replacement is found, you will be refunded all your money except for a \$25.00 per person cancellation fee.**
- If less than 30 passengers sign up for this trip, MCCoA reserves the right to cancel the trip or make any necessary changes to conduct the trip with a reduced number of passengers.
- Parking will be available in the parking lots at all locations. **Please plan to arrive approximately 15 minutes prior to the scheduled departure time.**
- The dress for attractions is casual.
- You can bring snacks and drinks on the bus.
