## DAY 1: FLIGHT TO ALBUQUERQUE:

Fly to Albuquerque, New Mexico, founded in 1706, where you will meet your Tour Director and enjoy a stop in historic Old Town to stroll the historic adobe buildings that house over 150 shops, galleries and restaurants. Also see the icon of Old Town, the San Felipe de Neri Church. Later check into your hotel for a two-night stay and witness the Balloon Glow, where just before dusk burners from hundreds of balloons light up the evening sky.

## DAY 2: DAWN PATROL - MASS ASCENSION - SANTA FE CITY TOUR - BALLOON GLOW

Today experience one of the most photographed events in the world, the Albuquerque International Balloon Fiesta. Early this morning view over 100 colorful balloons from around the world at Dawn Patrol, followed by the Mass Ascension. The balloons make the sky become a pallet of multicolored orbs dancing in the cool morning light. Later take a short drive north to discover Santa Fe, the upscale resort and artist community with Spanish-Pueblo roots. Enjoy a wonderful Santa Fe City Tour including details about the history, culture and unique architecture of this interesting city. See the Plaza, Loretto Chapel and the Palace of the Governor's, a Santa Fe landmark built in 1610. Enjoy a bit of time at your own pace in this historic city to explore the many art galleries, museums, restaurants and shops. Later enjoy a

Welcome Dinner at a local restaurant in the Santa Fe area before returning to Albuquerque.

## DAY 3: ALBUQUERQUE - FLAGSTAFF

This morning board your motor coach and enjoy the scenic drive west to Arizona. Arrive Flagstaff, located in north central Arizona, situated at the base of San Francisco Peaks, a 12,633-foot-high dormant volcano and check into your hotel for a three-night stay. Tonight enjoy dinner with your fellow travelers.

The trolley guide will give you insight into the various rock formations indigenous cacti and history of this remarkable area. Enjoy time in Uptown Sedona filled with art galleries, shops and restaurants. Return to Flagstaff and enjoy the remainder of the day at leisure.

## DAY 5: FLAGSTAFF - GRAND CANYON NATIONAL PARK - FLAGSTAFF:

This morning visit the South Rim of Grand Canyon National Park. Six million years in the making, the Grand Canyon's dynamic colors and textures inspire reflection at nature's power and beauty. Experience

this one-mile deep 277-mile long chasm with its myriad of constantly changing colors and plateaus. Enjoy time on your own to maybe take a short hike, walk along the South Rim Trail, do a bit of shopping, explore the historic El Tovar Hotel or enjoy one of the park's famous ice cream cones. Later stop to see vistas from the historic Desert View Tower. Once out of the park visit famous Cameron Trading Post, well known as a stop for park explorers and Native American art. ## DAY 6: FLAGSTAFF - PAGE/LAKE POWELL AREA

Today drive north to Lake Powell to enjoy a scenic & relaxing Lake Powell Cruise taking in the breathtaking views of the second largest man-made reservoir in the US. Later check into your hotel for the next two evenings in the Page/Lake Powell area. The evening is at leisure to enjoy dinner on your own.

## DAY 7: PAGE/LAKE POWELL AREA - MONUMENT VALLEY - PAGE/LAKE POWELL AREA

Enter the Monument Valley Navajo Tribal area offering vistas of stunning rock formations on your way to Monument Valley, the most filmed area in the west & setting for many of John Ford's movies. Enjoy an included lunch before a Monument Valley Scenic Drive Tour with a knowledgeable Navajo Guide aboard a four-wheel vehicle. Explore the areas oddly shaped monoliths, buttes and mesas of red sandstone while learning more about the Navajo





way of life. Later return to your hotel for an evening at your own pace.

#### DAY 8: BRYCE CANYON NATIONAL PARK
