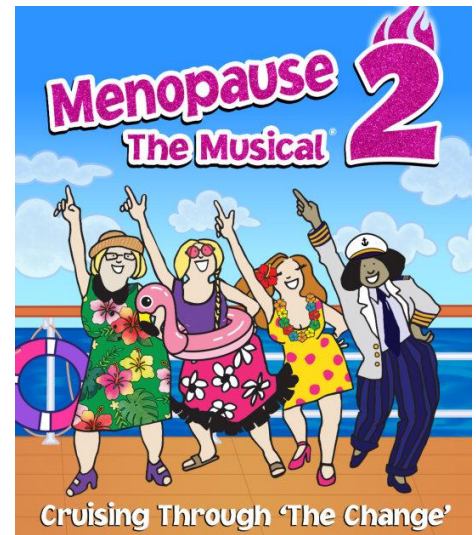
5:15 pm Arrive at Honeywell Center in Wabash IN for buffet dinner
