How I am paid	Wealth Today initially receives all fees received from my clients and product providers and distributes them to me after their fees and other expenses are deducted. Implementation	Your Terms of Engagement (ToE) will detail all Implementation Fees and will be signed by you, before any work is carried out. If you elect to proceed with our advice a \$380 implementation fee plus 0.65% fee based on the value of your investments will apply. For example, for investments valued at \$100,000 the implementation fee would be \$1,030.
