# Frequently Asked Questions on OPM's **Deferred Resignation Program email**

What is the Deferred Resignation Program?

The Deferred Resignation Program ("Program") was introduced by an email sent to federal employees on January 28, 2025. Preceded by threats to modify and downsize the federal workforce, the Program purports to allow federal employees to submit a resignation letter that will become effective on September 30, 2025.

In exchange, the Program claims that employees will be exempt from "Return to Office" requirements and will maintain their current compensation and benefits until the effective date of their resignation.

Employees should not take the Program at face value. The Program documentation, including the introductory email, an associated guidance memorandum issued by the Office of Personnel Management Incentive Payment ("VISP") ("OPM") on Jan. 28, 2025, and OPM-issued FAQs are riddled with inconsistencies and uncertainties.

It is also unclear whether OPM has the legal authority to support the Program or its alleged benefits, and the eligibility criteria are vague.

2. Is the buyout? Is the Program a

No, the Program is not buyout nor is it a Voluntary Separation program. Instead, it purports to offer employees the ability to submit a deferred resignation and claims employees that do so will continue to receive pay, while still possibly working, until September 30, 2025.

Notably, however, the Program contains no guarantee that an employee's resignation will be accepted. Nor does the Program guarantee that

The City of Warner Robins hosted a Vietnam Veterans Memorial Land Tribute on Friday, Jan. 17. marking the beginning of a new journey for the city and local

veterans. It had been a long wait for veterans to see a memorial honoring those who did not make it back home. Soon, they will finally have a place where everyone remembers

their sacrifice. The memorial will be on Vietnam Veterans Memorial Parkway, named in

April of 2009. The event started with Mayor

LaRhonda Patrick welcoming attendees, saying the location will soon have a wall honoring the 1,584 Georgians who did not return home from the Vietnam War.

The memorial will be in two phases, the first an outdoor portion with statues and a memorial wall. The second phase will be the construction of a building.

Construction will start this year and, as of right now, the timeline is unsure. Patrick said a proposal request has been submitted,

and the city will know a timeline in approximately 45 days. Patrick said the event was for those who never walked on Georgia soil again, their

families, their loved ones and those who

did return but did not receive the welcome

they deserved.

Patrick also recognized Bill Carey and Tom McClendon for being pioneers in the initiative, which started in 2011.

Carey is a member of the Veterans Issues Board and of the Romeos, a Vietnam veterans group. He thanked participating organizations for attending the event and believes it is time to give their brothers at rest at

Patrick also gave thanks to Michael Driggers, who donated five acres of land to the city. Driggers is a Vietnam Veteran and always wanted a place people could come

and remember. "It's because of my heart for

# **DAF Safety announces next** generation safety reporting

KIRTLAND AIR FORCE BASE, N.M. - The next iteration of digital safety reporting is here with the release of the new SAFEREP App. SAFEREP is the Department of the Air Force's only completely digital safety reporting tool supporting all disciplines and areas around base, with dedicated reporting features for workplace, traffic, industrial, flight, weapons, and space safety. Replacing the Airman Safety App, SAFEREP reflects a broader reporting capability that encompasses more functional areas and other military services.

SAFEREP will allow users to submit more than just hazards. Users from every career field will be able to voluntarily submit workplace and installation hazards, unintentional errors, and supervisor's mishap reporting. Aviation-specific reports are also available to aircrew and maintainers. SAFEREP will also break out the different operational disciplines to provide a clear distinction between avenues of reporting. All data is passed to the appropriate major command or down to the installation, and resources can be allocated to resolve issues.

"Anyone can use SAFEREP, regardless of rank, pay grade, uniformed or civilian status, or occupational specialty," said Jason Wollard, SAFEREP program manager. "If an Airman or Guardian thinks the issue could cause damage, injury, illness, result in a serious incident, or an accident, then they should use

the app to report the concern to their safety office. They should also let their supervisor know as soon as possible, especially if they were involved in an accident or were injured."

All SAFEREP users will be able to quickly and easily tell Safety about issues in the dorms, at work, or anywhere on base. Dangerous conditions, near misses, and cultural issues that could lead to an accident can all be reported using the App. Addressing these issues and learning from mistakes helps prevent injury and damage, while also creating a better work culture and environment.

Aircrew, including maintainers, aerial port workers, and airfield operations, can report hazards related to in-flight operations, maintenance operations, or issues on the ramp. Additionally, aviation-specific reporting options including Aviation Safety Action Program reports, and other required safety reports such as hazardous air traffic reports, wildlife strikes, unusual occurrence or in-flight emergency reports. Serious aviation hazards, near misses, and aviation ASAPs provided to SAFEREP are posted to the SAFEREP display to enable community-wide visibility on

"Safety professionals are experts in their work areas and know what 'right' looks like," said Wollard. "However, Safety can't be everywhere, all at once, all of the time. SAFEREP allows Airmen and Guardians to inform Safety about hazardous conditions or cultural issues that concern them.'

Reporting in SAFEREP is simple. Users can either download the app or go to the SAFEREP website. Once there, users will select their service, the type of report being submitted, and then the app will guide users through the rest. Submissions to SAFEREP can also be made while TDY to report concerns to the local safety office. Users also have the option to submit a report anonymously.

"SAFEREP is the DAF's premiere safety digital reporting tool," said Maj. Gen. Sean Choquette, DAF chief of safety and AFSEC commander. "It empowers Airmen and Guardians to speak up about issues they see and mitigate risks before they cause a mishap. By preventing mishaps before they happen, we increase our readiness and create more lethal Air and Space Forces."

If users already have the Airman Safety App downloaded, they will not need to download a new app as SAFEREP will automatically update. If users are not online, or not connected to the internet, SAFEREP will store up to 100 draft reports until connected to the internet to complete the submission. Temporarily, the Airman Safety App website will redirect users to SAFEREP but the Airman Safety app will be fully discontinued at a later date.

# How to recognize phony debt collection calls, texts

ebt collection scams can be one of the most frightening and persistent scam types. Victims often report that scammers harass them or their family members for weeks or even months, both at home and at work, trying to get them to pay a debt they don't BBB receives numerous reports of con artists

changing tactics just to get the information necessary to collect information or cash.

### How the scam works:

The scammer calls or texts and says that they work for a loan company, law firm or government agency, and claims to be collecting an overdue payment for you or a family member.

After replying that you or your family member don't owe money, the "debt collector" starts threatening to file a lawsuit, have wages garnished, request an arrest warrant, or arrange for a court appearance thousands of miles from

All of these claims are nerve-wracking, leaving the person answering the phone not even sure they owe money in the first place.

One consumer reported their experience with a debt collection scam to BBB Scam Tracker: "Family member was contacted being told that this company was looking for me to deliver papers to me. I contacted the company and was told that a loan from [company name redacted] had been taken out in my name back in Nov. 2012. I had no clue about this loan but was told that I was going to be served with papers and have a class three felony on my record if convicted of defrauding a bank institution if I didn't settle the matter today." This consumer reported losing \$1,489. If you receive a phone call like this, the first

thing to do is to stay calm. Despite these threats, these "debt collectors" don't have any legal



alleged overdue loan doesn't even exist. Don't give in and pay the money you don't owe, otherwise, they'll call back for more.

The "good cop" ver-

An unsolicited call comes through from a

debt collection agency. The caller claims there is an unpaid debt from long ago that is about to go to court. The person speaking is polite at first and appears to have your best interests at heart.

They seem like they sincerely want to help avoid the court date. To fix the situation, all you need to do is make a reasonable payment, perhaps even divided up into several installments.

No matter how kind the caller seems, don't fall for it. If you make the payment, the person you spoke to on the phone will take the money and disappear. Any future efforts to contact them will be in vain.

### Tips to spot this scam:

Ask the debt collector to provide an official 'validation notice" of the debt. In the U.S. and most of Canada, debt collectors are required by law to provide this information in writing. The notice must include the amount of the debt, the name of the creditor, and a statement of your

If the self-proclaimed collector won't provide the information, hang up.

Ask for proof of the debt and of the agency calling. If you do owe money and aren't sure if the caller is real, ask for their name, company, street address, and telephone number. Do not provide any bank account, credit card, or other personally identifiable information over

## Medal of Honor spotlight

# **Marine Corps 1st Sgt. Jimmie Howard**

Tot a lot of people have the skill and demeanor to keep their counterparts focused during an overwhelming battle. However, Marine Corps 1st Sgt. Jimmie Earl Howard was a natural leader and managed to keep the majority of his platoon alive during a lopsided hours-long firefight in Vietnam. His courage and leadership earned him the Medal of Honor.

ers and a sister and enjoyed playing football while growing up, doing well enough at the sport to earn a spot on The Des Moines Register newspaper's All-State team in 1948.

After graduating from Burlington High School in 1949, Howard studied for a vear at the University of Iowa before deciding to take his life in a different direction. In July 1950, he joined the Marine Corps, graduating from recruit training the following January.

Howard spent a year in San Diego as a drill instructor before completing advanced infantry training in February

Howard was born on July 1952. He was then ordered to 27, 1929, in Burlington, Iowa, Korea, where he served as a to Raymond and Edythe forward observer with the 1st Marine Division. During his deployment, he was wounded three times and earned the

He returned to U.S. soil in April 1953, then spent the next decade of his life serving in various capacities in the San Diego area. At some point, Howard married a woman named Theresa. They went on to have five daughters and a

18-man platoon was deep into enemy-controlled territory near Chu Lai, Vietnam, searching for enemy troops to call air and artillery strikes on from the top of Hill 488, which later became known as Howard's Hill. It was about 1,500 feet and dominated the terrain for miles, historians said.

There was no place to hide on Hill 488, and the enemy knew it. However, Howard's platoon still spent two days on the hill carrying out their mission without being bothered.

Shortly before midnight on June 16, that changed. A battalion-sized Vietcong force launched a vicious attack on Howard's platoon using small arms, automatic weapons and mortar fire.

Their chances of survival didn't look good, but Howard jumped into action anyway, determined to defend his men, most of whom were only about 18 years old. He quickly organized the platoon into a tight perimeter defense and calmly moved from position to position to direct the fire of his young Marines. They continued to hold their ground for hours overnight during wave after wave of assaults.

According to Howard's Medal of Honor citation, his courage and firm leadership inspired and motivated the men around him to continuously repel the furious fire, despite how seemingly hopeless the situation was. At one point, when they ran out

an employee's whose resignation is accepted will receive the benefits that the Program purports to offer.

3 es to accept the pro-If an employee choosgram, are they required to work during the deferred resignation period?

They may be. OPM's statements are conflicting on this point. According to the OPM email and letter, employees will not be required to work in person but may be assigned remote work duties. The OPM FAQ page also suggests that employees will not be required to work except in "rare cases," without defining what constitutes "rare

At the same time, the FAQs describe the deferred resignation period as a "nice vacation" and the Program states that employees may be placed on "paid administrative leave." Can an employee take

•another job during the

deferred resignation period?

The FAQ states that the resignation letter does not explicitly prohibit outside employment. However, other existing policies, such as agency-specific regulations requiring prior authorization for outside work, are likely to apply.

Are an semployees eligible for Are all the program?

No. Employees in positions related to immigration enforcement and national security, as well as those in any positions specifically excluded by their employing agency, are not eligible. USPS employees and military personnel are also excluded. There is no guidance on how employees can confirm their eligibility or if their agency has

Will employees who Oopt-in be protected from termination before their resignation date?

Nothing in the Program documentation purports to prohibit the termination or separation of an employee who accepts deferred resignation. While

the OPM email suggests that employees will maintain their compensation and benefits until the effective date of their resignation date, it does not explicitly state that employees are shielded from layoffs or other adverse actions before September 30, 2025. There is no guarantee that employees opting in to the Program will not be targeted for The Program also does not

indicate what may occur in the event of a lapse in congressional appropriations. At present, many agencies of the federal government are only funded through March 14, 2025. What happens if an

7 • agency requires an employee to continue working despite OPM's FAQ stating that continued work should be

While OPM's FAQ states that work will only be required in "rare cases," the program's details vary across the different OPM documents. If an agency insists on continued work, employees may not have a clear administrative remedy, as the

enforceability of the promises and statements in OPM's FAQ is uncertain.

What legal recourse **o**do employees have if the government does not honor the terms of deferred resignation? It is unclear what recourse, if

any, employees might have if the government fails to honor the terms of their deferred resignation. There is no certainty that the statements made in the OPM Program documents will be legally enforceable. Even if the email and FAQ page are interpreted as an implied contract or offer, there is no guarantee that such a claim would be enforceable. For example, while each case will be fact-specific, resignation is generally considered to be a voluntary action. It is therefore unclear whether violations of the policy would be appealable to the Merit Systems Protection Board, through the grievance process, or any other How can employees

9 ensure the administration will follow through on the

**Program?** 

Given the inconsistencies between Program's various documents issued by OPM, as well as the ambiguous and conflicting language regarding work obligations and exclusions, there is no guarantee that the claims in the Program will be honored by the Government. The Program may also face legal challenges that could alter the terms of all or portions of the Program. Employees who opt-in to the Program will be at the mercy of the administrators of the Program, whose claims contain inconsistencies and lack stated legal underpinning. Is there an

O assurance that the promised continued salary will be funded? No. Nothing in the OPM doc-

umentation contains such an assurance. Moreover, because current appropriations for most civilian agencies are set to expire March 14, 2025, it is not guaranteed that agencies affected by the current appropriations bill will continue to have adequate funding for the promised salary

beyond the bill's expiration.

What actions Locals Councils take to protect bargaining unit employees from the Program? Locals and councils may:

Consider filing requests for

information under 5 U.S.C. § Consider filing a demand to

bargain over the Program.

Consider grievances alleging the Program violates terms of their collective bargaining agreement or regulations (e.g. regulations concerning administrative leave).

Locals and councils may also have a basis for a grievance or unfair labor practice charge alleging, among other things, a bypass of the Union with respect to communications about the Program directly to employees.

Vietnam Veterans that I feel like they should be recognized for the service that they gave. I'm proud to be in a community that's going to get the ball rolling and get this thing going. I'll be here often," he said.

Congressman Sanford Bishop was also at the event and has worked with Patrick over the past months to bring this memorial to the community.

Bishop said he was proud to support the memorial and said he will always ensure America provides the highest quality of care and benefits for veterans and their families. He also said he will always make sure their sacrifices are recognized and honored.

Bishop said a memorial is a place reminding people to stop and reflect, as well as to pay respect.

"The Vietnam Veterans Memorial will help preserve the legacy of our service members, the stories of their valor, the weight of their sacrifice and

the lessons we must draw for a better future," he said.

Bishop said projects like the memorial are personal to him because he remembers his childhood friend, Thaddeus Williams, who passed away while serving in the Army.

He then recognized McClendon with a certificate of special congressional recognition. McClendon spent a decade fighting for the memorial by challenging mayors and members of congress.

Representative Shaw Blackmon also spoke at the event and presented House Resolution 17. The resolution honors those who were victims of Agent Orange. The memorial will pay homage of those victims since they are not currently recognized as victims of the Vietnam War.

Patrick said on the wall there will be many names' veterans will know, it will be the names of those they served alongside and tried to protect during the war. The wall will also have the name of Patrick's great uncle, and she plans to teach her son about the war. She said the memorial will represent something

"We've been working so hard as a team, staying focused on each phase as each year comes in. This is the year of execution for the city of Warner Robins," she said. "You can finally see the things we said we're going to do and see something physical to show you that we meant what we said and we're doing it. So, being able to show everyone that the things we could happen, did happen, it's what really warms me up the most."

of grenades, Howard encouraged the Marines to throw rocks at the enemy, exhibiting imagination and resourcefulness in their defense.

At another point, the fragments of an exploding enemy grenade lodged into Howard's back, wounding him severely and keeping him from moving his legs. However, he refused to be given morphine, historians said, because he knew its effects would make him drowsy and therefore ineffective. Instead, Howard dragged

himself along the defensive

perimeter to distribute his ammunition to the rest of his men, all while maintaining radio contact to direct air strikes on the enemy with uncanny

By the time dawn came around, five Marines had died and everyone else was wounded — but Howard's platoon still held Hill 488.

When evacuation helicopters made it to the area, Howard initially warned them away. He wanted to make the landing zone as secure as possible, so he first called for more air strikes, which he directed along with his platoon's own fire onto enemy positions. Only afterward did they finally evacuate.

Howard's leadership and bravery were key to preventing his entire platoon from being killed. Despite the casualties they did suffer, his men still managed to eliminate about 200

combatants during the 12-hour

Howard was transferred back to the U.S. and assigned to a training unit in San Diego. On Aug. 21, 1967, shortly after being promoted to gunnery sergeant, he received the Medal of Honor from President Lyndon B. Johnson during a ceremony at the White House. His wife and six children were able to attend, as were his mother and stepfather.

Howard remained in the the Indo-Pacific region.

Marine Corps for another decade before retiring in 1977. He and his family decided to remain in San Diego, where he went to work as a civilian for the Department of Veterans Affairs. He also volunteered to coach various youth sports in the community, including as an assistant coach for the Point Loma High School football team.

Howard died in his home on Nov. 12, 1993. He is buried in Fort Rosecrans National Cemetery in San Diego.

In his honor, the Arleigh-Burke class destroyer USS Howard was commissioned in October 2001. The ship currently serves in the U.S. 7th Fleet in

have details on the accounts in question. Stay calm. Debt collectors are not

allowed to harass people even if they do owe money. **Protect yourself:** 

Just hang up. If you don't have any outstanding loans, hang up. Don't press any numbers or speak to an "agent."

Never provide payment to someone **you don't know.** If you're being urgently asked to provide payment over the phone to someone you don't know, hang up. Scammers often ask for payment through wire transfer, prepaid gift cards, or digital wallet apps. Take these as red flags for a

Reach out to your loan providers to verify the information. If you currently have loans taken out and aren't sure if the caller is real, call the banks or loan companies on your own and verify if what the caller states is true. Be sure to look up their customer service phone numbers on your own and never use a phone number that a potential scammer is using or provides

Check your credit report. In the US, check with one of the three national credit reporting companies (Equifax, TransUnion, Experian). This will help determine if there are outstanding debts or if there is suspicious activity.

Place a fraud alert on your credit report. If the scammer has personal information, place a fraud alert with the three national credit reporting companies. Remember that while most debt col-

lection agencies are legitimate, there may be times when a scammer is phishing for information. For more information on how to avoid this scheme, visit BBB.org/ AvoidScams. If you've been targeted by a debt collection scam, be sure to report it to BBB.org/ScamTracker.

- 1 pound ground beef
- cup stout beer tablespoons flour

- tablespoon Worcestershire sauce

- cup beef broth 1 bag (28 ounces) hashbrowns with
- peppers and onions can (14 ounces) carrots, drained

- sheet puff pastry, thawed

Heat oven to 400 F.

In large skillet or Dutch oven, brown ground beef; drain and set aside. Over medium heat, deglaze skillet with beer and whisk in flour. After thickening, whisk in tomato puree and add Worcestershire sauce. Mix in ground beef, garlic powder and beef broth. Add hashbrowns, carrots and peas. Season with salt and pepper, to taste. Simmer 20-25 minutes, stirring occasionally.

Place puff pastry sheet on cookie sheet. Beat egg and brush over pastry. Bake 10 minutes. Place hot puff pastry on top of beef mixture and serve.
