As we just celebrated Resurrection Sunday, which is the ultimate “Gift of Life”, we are excited to share with you about one of our clients who reached out to us during a dire situation, needing encouragement and hope of being able to give life to her unborn child.

She stated at her initial appointment that she had recently separated from her husband who was now living in a different country. She and her three young children had no choice but to move in with her dad who was experiencing major health issues. This precious mother stated that she was very scared and did not feel confident that she could take on caring for yet another baby at this time.

After a tear-filled discussion with her peer counselor about what her options were, the client stated that she would consider placing her baby for adoption. Praise God, she was thinking that adoption may be an option for her instead of an abortion.

Her peer counselor listened with compassion that day, informing the client of all the ways we could help her, not only with her current pregnancy but also with her youngest child as well. The client left that day promising to let us know her decision.

She called one week later to let us know that she decided not to place her baby for adoption. She was choosing life and going to parent herself.

Imagine how different her outcome would have been had we not been there for her that afternoon when she reached out to us. How many other women are in a similar situation, that simply need a listening ear and someone who will walk alongside them through what otherwise feels like an impossible situation?

We continue to fight a battle that puts PRC of Flint on the front lines but this is not a battle that can ever be fought alone.
