New Class Action Lawsuit Filed Against GM Over Defective and Cracking C7 Corvette Wheels



It's been reported for years that some owners are experiencing problems with their wheels cracking on **CA Z06s and Grand Sports.** A <u>Pennsylvania law firm</u> is asking affected owners to contact them to take part in a class-action lawsuit against General Motors. Kehoe Law Firm, P.C., says the class action has been filed in United States District Court, Northern District of California on behalf of owners of 2015-2019 Corvette Z06s and 2017-19 Grand Sports.

Kehoe Law Firm, P.C., says the class action has been filed in United States District Court, Northern District of California on behalf of owners of 2015-2019 Corvette Z06s and 2017-19 Grand Sports. According to the complaint, said defect is a result of making the rims out of a cheaper cast material instead of being forged, and also because GM used less material than necessary to try and save unsprung weight (or weight that is not borne by the cars' suspension), resulting in cracks under normal driving conditions because the rims are too weak.

June 30th is National Corvette Day. On June 30, 2020 it will be 67 years since the first Corvette rolled of the line on June 30, 1963. On June 26, 2008 Rep. John Simkus from Illinois and 55 of his colleague proposed House Resolution 970 which states the following:

Whereas the Chevrolet Corvette is America's first sports car;

Whereas the first production Corvette rolled off a Flint, Michigan, assembly line on June 30, 1953;

Whereas the Corvette is now manufactured in Bowling Green, Kentucky;

Whereas the Corvette is the most widely respected production sports car in United States history;

Whereas the Corvette is truly a symbol of American pride;

Whereas General Motors is celebrating its 100th anniversary in 2008; and

Whereas the 30th of June would be an appropriate day to designate as 'National Corvette Day': Now, therefore, be it Resolved, That the United States House of Representatives supports the designation of a 'National Corvette Day' to honor the Chevrolet Corvette."

June 30th falls on a Tuesday so hopefully the quarantine situation will be such that HDCC can have a function to celebrate.



2021 Chevy Corvette C8 First Details Emerge: Find Out What's New

Some of the highlights include two fresh paints – Red Mist Tint coat and Silver Flare – which according to <u>Corvette Blogger</u> will come to replace Long Beach Red and Blade Silver, respectively. It's a bit unusual to see such a change after just one model year, but it appears <u>Chevy</u> is looking to update the color palette already. The former is said to be in the same vein as Crystal Red Metallic and Magnetic Red Metallic, while the latter might have already been revealed on the C8.R.

A visible carbon fiber finish for the high-wing and the door intake trim will be available for the 2021 <u>Corvette</u>, along with a bunch of body stripes in a multitude of colors. Sadly, the visible carbon fiber ground effects option will remain unavailable for the time being. On the flip side, the good news is customers will be able to get the Magnetic Selective Ride Control as a standalone option without having to go for the <u>Z51</u> package.

There are some changes inside as well where wireless Apple CarPlay will become standard across the entire range and the 3LT will be offered with a couple of new seat combos. All-weather floor liners are also listed, along with a car cover depicting the <u>C8.R race car</u>. We're not sure what the "Stingray R" theme is about, but *Corvette Blogger* speculates it might have to do with a special-edition model with visual upgrades derived from the C8.R. Attached below is an image that emerged last month showing what might be the Stingray R as depicted in Chevy's visualizer.





Winter Storage

As we all know, it is recommended that when storing your Corvette for the winter months, you should fill the tank and add fuel stabilizer. It has been reported that Corvettes C4 to C7 are experiencing fuel gage problems because the sulfur in the fuel causes the fuel sender card to fail resulting in false readings. The article states you will get a reading of slightly less than full and then as you use the fuel the gage starts to show the correct amount of fuel in the tank. The next thing that happens is the gage will suddenly show you are close to empty. The article then recommends that when you store your car you should have less the ¹/₄ of a tank of fuel. In the past when storing your car it was recommended that the tank be full so as to prevent condensation.

The fix is to remove the fuel tanks and replace the sending units. As you can imagine, this is not an inexpensive event.

The second issue Dave mentioned is that if you disconnect your battery the clock will quit or show in incorrect time. Dave stated he has experienced this problem. Apparently the disconnect with the satellite does not re-establish with the car so that the time shows incorrectly. This pertains to C6s that have navigation. Dave stated that there is a fix on a CD that will correct the problem. This assumes that you still have a CD player in your Corvette. You can also go you to the dealer and they can do a software update.


