

Futurist Ethics: Using our Moral Imagination

Questions we may ask to reflect (our own thoughts, forecasting, and imagination) and to engage others in futurist discussions:

- How is society changing?
- How might SW practice change?
- How can we prepare – morally/ethically – for these changes?
- How can we take moral leadership on changes?
- How can we be proactive & build on moral opportunities?


Privatization



NASW COE 2017: Tech Updates – 1.06


- Avoid communication with clients using tech for personal or non-work purposes
- Be aware posting personal information on websites might cause boundary confusions, inappropriate dual relationships, or harm to clients
- Be aware that personal affiliations may affect ability to effectively work with particular clients
- Avoid accepting requests or engaging in personal relationships with clients on social networking sites


Assessing Ethical Goods and Ethical Risks




