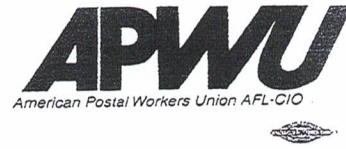

Important Election Voting Information

The Wilmington DE M.T.S. Area Local 152, Election of Officers ballot voting will be conducted by The American Arbitration Association. This organization has conducted the local's elections for the past 15+ years. All ballots will be mailed from, and must be returned to, this firm.

To be eligible to vote in the election of officers, you must be a member in good standing. Your 1187-form must be signed, submitted, and dated by you prior to May 2, 2026. Supervisors who pay dues are not permitted to vote. 204-Bs are permitted to vote because they hold acting, not permanent, supervisory status.

Mail handlers who pay full dues to the APWU are permitted to cast a vote for general officers only. Division (craft) officer votes can only come from members of that same craft. Ballots will be mailed out on October 1, 2026, and must be returned no later than October 23, 2026. The ballots will be counted on October 26, 2026, at 10:00 am. As the Chairperson, I along with another committee member, will be present to observe the American Arbitration Association's handling and counting of the ballots. Each candidate may be present to observe during the counting of the ballots.

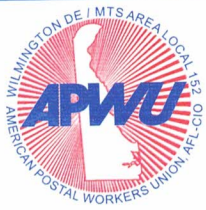
If a ballot is undeliverable, it will be returned to American Arbitration Associates, they will scan it and email it to me the Chairperson, I and the committee will attempt to locate the member, obtain a corrected mailing address, and provide it to the firm for a second mailing.
