CONTINUE TO COLLECT TWICE A YEAR FOR THE TIME BEING.  
SO COME DECEMBER YOU WILL RECEIVE FROM THE STATE  
SECRETARY AN INVOICE FOR THE AMOUNT TO BE PAID. THEN  
IN JUNE YOU WILL ONCE AGAIN RECEIVE FROM THE STATE  
SECRETARY AN INVOICE FOR THE AMOUNT TO BE PAID.**
