PLEASE NOTE THE INSTRUCTIONS AT THE TOP OF THE CONVENTION REGISTRATION FORM.

Do not enter anything in the shaded cells. If you are using the PDF form, you can type your information directly into the form using any PDF reader.

Please List all Delegate, Visitors & Alternates (Approved on Aerie floor) in Alphabetical order. **The Brothers** Name must appear as entered on their Official Receipt and include their GAID.

List all Delegates, who are Past Aerie Presidents on the right side of the Delegate Form. List Aerie Delegates (Approved on Aerie floor) in the Top left side of the form. List all PSW Presidents and State Officers in the appropriate space on the Delegate Form. Current State Officers are paid for by the State Officers fund.

Please Pre-Register all "Out of State Dual Members" that plan to attend the Washington State Annual Convention.

Alternates will get a Visitor (non-voting) credential. At such time as the Aerie President or Secretary notifies the Credential Committee that the alternate will replace one of the Aerie's listed Delegate's, the Alternate will be changed from Alternate to Delegate and a new credential will be printed.

Per SECTION 2.2 of the Washington State Aerie By-Laws, each Aerie is allowed **one** (1) **Delegate per 100 members** or major portion thereof, based on the number of members on the rolls in December preceding the Annual Convention. A Past Aerie President, in good standing, need not be counted in your Aerie Delegate count.

When you have completed the Delegate Form (Please check that the Aerie Name & Number have been filled into the box at the top and a contact number has been entered in case there are questions) then send it to the address shown below, along with a check for the total amount owed for each Name on the Convention Registration Form. Must be postmarked prior to June 1st. **Do not send payment for Alternates**.

Per Section 9.4, 94.1 and 9.4.2 of the Washington State Aerie By-Laws the registration fees are:

- 1. \$12.00 for each name on the form if postmarked no later than the first day of June.
- 2. \$15.00 for each name on the form if postmarked after the first day of June or registering at the convention.
- 3. \$12.00 for all Visitors.
- 4. Alternates are free so **do not send payment for Alternates**.

Per Section 2.2 of the Washington State Aerie By-Laws:

No Aerie Delegate shall be seated unless all required reports are filed, and the Per-Capita Tax (State Aerie and Grand Aerie) is Paid in Full by June 1. For the purposes of the registration process, these requirements should be met at the time you send in the registration form.

These sections of the Washington State Aerie By-Laws will be strictly adhered to. Per-Capita checks *cannot* be accepted by the Credential Committee at the Annual Convention, they must be paid to the Washington State Secretary. Take the receipt showing that the Aerie Per-Capita Tax is paid up to date, to the Credentials Committee to register your Aerie Delegates for the Annual Meeting.

You can find a copy of both the Convention Registration Instruction letter and Convention Registration Form on the Washington State Web Site: waeagles.org and click on Registration Forms. The Letter and Convention Registration Form are in PDF format. This requires that you have Acrobat Reader, (from Adobe, Acrobat Reader is free), installed on your computer to be able to open the letter & form in (.pdf) Format.

Do not mail Delegate List and Check for Registration Fees to Washington State Secretary or to the Host Aerie.
