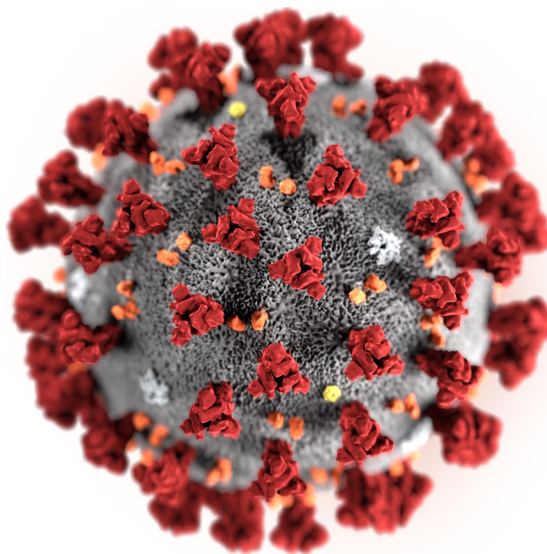

Subject: Status of Eagle Valley Opening for the 2020 camping season

Dear Board Members,

I am sure each and every one of you have been waiting for a response to the results of the questions asked: 'Yes, we should open' or 'No, we should not open at this time'. The response from the 26 board members is as follows: Six votes for - Yes; Twelve votes for – No; and Eight no responses. In fairness to those that didn't respond, it is ok, the instructions were if you didn't respond it was considered a 'No' vote. So, what does this mean and what next.

Presently Governor Insley has signed a statewide order that requires everyone in the state to stay home. The order will last for two weeks, ending on the 6th of April but could be extended. At present, all State property is closed to camping until the 30th of April and that could be extended to a later date. We have a responsibility to our home and family first, as well as the safety of all around us. From the latest reports the best way we can do this is to practice social distancing and stay home as much as possible. As Governor Insley stated when he issued the 'Stay at Home' order, "The less time we spend in public, the more lives we will save."

I think we need to continue to monitor the corona virus status and modify our action when it is safe to do so. Maybe and hopefully the Valley can safely be up and running to support the Memorial Day Weekend.

I have participated 20 years or more of reopening's, some harder than others but all being a lot of hard and dirty work. Some opening work parties saw only four or five of us doing what needed to be done. In the last few years, through camping incentives, we have had a very noticeable and appreciated increase of volunteers. But one constant for all reopening's, once started you cannot just go home the next day someone must stay to safeguard the Valley's property.

It takes approximately 4 days, if all goes right, to bring the water system back on line and then requires several tests to be run by a water testing lab. At the same time a seasonal water system start-up procedure must be performed, followed by the submission of a completed DOH certification form to DOH Eastern Regional Office, Spokane Valley, WA.

We do have new Caretaker and Office manager lined up and ready to go. They very much want to do the job, but want to be safe and act in accordance with Washington State guidelines and the Valley's requirements. It would be in my opinion inappropriate to leave them alone without several weeks of training.

At the present time Kittitas County Public Health District has issued a stay-at-home order for Kittitas County. It falls in line with Governor Inslee's Stay Home – Stay Healthy proclamation. The county order will be reviewed on the 3rd of April and if extended will be reviewed every 10 days. KCPHD says vacation properties are non-essential services and booking a vacation rental at this time is in direct violation of the stay-at-home order. A violation of the order can be considered a gross misdemeanor and carry a fine of not less than \$10 or more than \$100 and or max of 90 days in jail. KCPHD recommend all Kittitas County vacations should be canceled during the stay-at-home order and rebooked for a later date.

For the last five years or more I have been looking for a person to take over the water system duties, but the several that I have found just didn't have the time free to cover the job. If anyone is interested and when the time is right, I would gladly guide you through the job and turn it over to you. Presently Karma and I have been performing the water startup and shutdown each year with the help of Ken Cross, but now with the loss of Ken, it is just Karma and me.

I will write a step by step startup procedure that I hope will be clear enough for a person to follow and successfully bring the water system on line.

Now as I said before, because of my weakened respiratory system from Sarcoidosis and my age I have been advised by my doctor to stay home for now. Karma as you know has several bad types of arthritis that are taking heavy tolls on many parts of her body. The medication that she takes lowers her immune system which makes her susceptible to almost any bug that comes down the road. She also has asthma which the doctor feels quite sure to have developed from conditions she was subjected to during her childhood days on a homestead in Alaska. The doctor has advised her to stay home as well. I would say age is a factor as well, but she might get mad at that. But the bottom line for now, and I am sorry to say, we will not be present for work at the Valley at this time.

I want to thank all who shared their thoughts with me and I want you to know this has been a very hard decision for me. Thank you again for your time and understanding that the majority rules. As we are witnessing, things and requirements are changing every day, state by state to county by county. At the present time, **no specific dates are set for the preopening work or the opening of the Valley for camping.** Please be safe!

 - Remove all paint stored in laundry room, utility room and walkway between men and women's bathrooms
 - Carefully remove all equipment from the big kitchen
 - Cleanup all camping sites (Rake up pine needles)
 - Start general cleanup of all buildings
 - Inspect the water system throughout the campground
 - Repair and damage found to the piping throughout the Valley
 - Start water system startup procedures (See startup instructions)
 - Perform Seasonal Water System Start-Up Procedure checks. (DOH 331-560)

William "Bill" Stotko Grand Aerie Outside Guard

Bill Stotko, Grand Worthy Inside Guard, joined the Fraternal Order of Eagles in September of 1977, joining the Monroe Eagles #2327 in Monroe Washington. He quickly became involved in the Fraternal side of the Fraternal order of Eagles, working his way through the Officer chairs of his home Aerie. Although Brother Bill was a Truck Driver by trade, he could always be depended on to step up when assistance was needed in maintaining his home Aerie.

Brother Bill became President of Monroe Aerie in 1997 – 1998 after working his way up through the chairs. Brother Bill has also held the position of Aerie President. Bill eventually had to transfer to Everett Aerie 13, in Everett Washington, following the closure of his home Aerie. Since his transfer to Everett Aerie #13, Brother Bill has the positions of Aerie President and Aerie Trustee as well as the Aerie Secretary. Brother Bill has held the position of Aerie Secretary, for 7 Eagles years in both the Monroe Eagles as well as the Everett Eagles. Currently, Brother Bill is once again filling the position of Aerie Secretary.

Brother Bill became the Washington State Aerie President during the 2010 – 2011 Eagle year after working his way up through the chairs beginning his journey at the Trustee level in 2001 - 2002. During this period, Brother Bill was also very involved in the initial development of the Washington State Aerie training program, being a part of the original group that put the training program together. Much of the training program was later adopted by the Grand Aerie in the development of the Grand Aerie Training program.

Brother Bill was selected from among all the Past State Presidents of Washington State to be the Pacific Northwest Reginal President for the Eagle year 2018 – 2019.

During this same period of time, Brother Bill has also been very active in working with Aeries in difficulty throughout the United States. Brother Bill's knowledge of the Grand Aerie Statutes as well as his respect for members rights, has given him the ability, working with these distressed Eagle Aeries and Auxiliaries, to bring them back into full compliance with our order.

Brother Bill has filled the position of Grand Aerie Elections Chairman for the last several years, being instrument in converting the election counting process into an electronic process that is able to tabulate the election count and provide results in hours rather than the days that it used to take. This same process was later adopted by the Grand Auxiliary as well.

Brother Bill and his wife Carey have been married for 33 years and have three children, Philip, Patricia, and Theresa. Additionally, Brother Bill and Sister Carey have seven Grand Children.

All applications will be held for 5 years from the time of receipt, with an automatic reviewing each year.

INDUCTION INTO HALL OF FAME:

The Hall of Fame Committee will announce the names of the 4 new Members, selected for induction into our Hall of Fame, at the Banquet on Thursday evening of the Washington State Convention. Their certificate into the "Hall of Fame" will be awarded to them at that time. The Committee will also read the names of the new Inductee's at the Friday Session. This schedule may be up for review and changed if necessary.
