2020 Annual Member Meeting Minutes: Read by Anna Placenti. Carolina Leal made a motion to accept the minutes as presented; Second by Cheryl Karcher, Motion passed unanimously.

Appointed Amendment Counters: Mark and Cheryl Karcher
Proposed Insurance Amendment: 49 Votes in the affirmative were needed to pass the proposed Amendment requiring Homeowners/Renters to have Insurance Coverage. Tabulation produced 52 votes in favor. Amendment Passed.

Proposed Quorum Amendment: Amending the quorum requirement from $51 \%$ to $33.33 \%$, reason being we have a difficult time getting enough owners to participate for quorum to hold member meetings. 64 Votes in the affirmative were needed to pass proposed Amendment. Tabulation produced 50 Votes, Amendment Failed.

Community Report: Phil Dent stated that there were 10 Sales Contracts, 7 had closed and 3 were Pending. Average Price was $\$ 139,000$. Sales in April were from $\$ 145,000$ to $\$ 162,000$. There are a total of 28 Unit Rentals. Power Washing of driveways and sidewalks has begun. 6 Lanais need repair with a cost of $\$ 15,000$ per Unit, we are still waiting on quotes from Vendors. Diane Zigrossi, CAM will be resigning effective 4/30/2021.
