NOTICE OF SEWER SYSTEM IMPROVEMENTS

The City of Fort Lauderdale is working with Lanzo Construction Co. to make improvements to the City's sewer system along SE 10th Avenue between SE 15th Street and SE 18th Court in Harbordale. Crews will be using a process called cured-in-place pipe (CIPP) lining, which is a trenchless method to rehabilitate underground sewer lines and extend their longevity while minimizing excavation and disruption.



- Full closure
- Partial lane closures
- Detour roads

WHAT

This work includes:

- Cured-in-place pipe (CIPP) lining of approximately 1,300 feet of sewer lines.
- Restoring the roadway, sidewalks and landscaping as needed.

WHERE

Construction will occur along SE 10th Avenue between SE 15th Street and SE 18th Court.

WHEN

Construction will begin on **Monday**, **August 25**, **2025**, and is expected to be completed by **late December 2025**. Work will take place **Monday through Friday between 7 a.m. and 7 p.m.**This schedule is subject to change based on inclement weather or other unforeseen circumstances.

TRAFFIC IMPACT

- SE 10th Avenue will be closed in both directions from SE 15th Street to SE 16th Street, including the intersections of SE 15th Street and SE 16th Street, throughout construction. Traffic will be detoured to Miami Road, Cordova Road and SE 17th Street.
 One lane in each direction of SE 10th Avenue between SE 17th
- One lane in each airection of SE 10th Avenue between SE 17th Street and SE 18th Court will be closed throughout construction.
- The right shoulder along southbound SE 10th Avenue between SE 16th Court and SE 17th Street will be closed throughout construction.
- Traffic control personnel will direct traffic as needed.
 - Please follow the posted signs and drive with caution in the area






Where/When are Our Meetings?
