

I like "Concept 3", but wanted to encourage posted education to all, on proper usage of a roundabout. If a sign could be made and posted on each respective street corner (on which there are presently stop signs erected). A metal reflective FDOT-type formatted sign with basic instructions could read something like the following:

## **USING A ROUNDABOUT**

- >Reduce your speed to 10-15 mph as you approach the roundabout.
- >Be aware of bicyclists and pedestrians; >Look left for oncoming traffic
- >Drivers entering the roundabout MUST yield to traffic already in the circle.
- >Do NOT STOP while in the roundabout (to allow someone in or for any reason at all).

Note: These rules apply to ALL VEHICLES and BICYCLISTS.

This is a very busy intersection but if everyone KNOWS how to use a roundabout properly, a sign such as this will likely reduce incidents and injuries while acclimating to the new design.

I see people frequently using roundabouts incorrectly, increasing the very statistics for which they are intended to abate; injuries and accidents.

The turn from 16th heading south On Cordova is dangerous. The corner has a blind spot for pedestrians trying to cross Cordova. While sitting at that corner it is difficult to see anyone standing on The sidewalk. The fence around our leased property, Studio 703, obstructs view. There are a/c condensers hidden in the fenced area. The condensers are closer than 35 feet to public walking sidewalk. This is a code violation.
