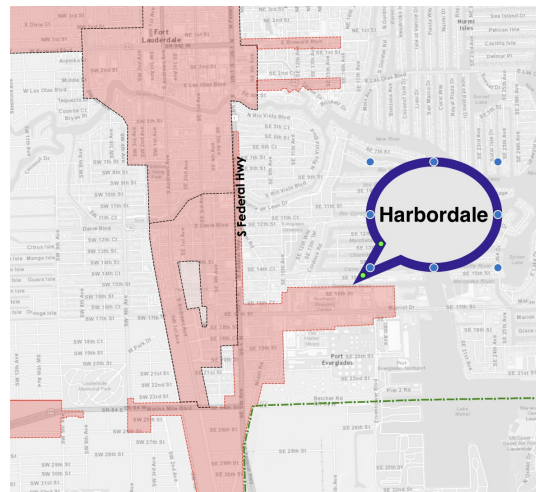

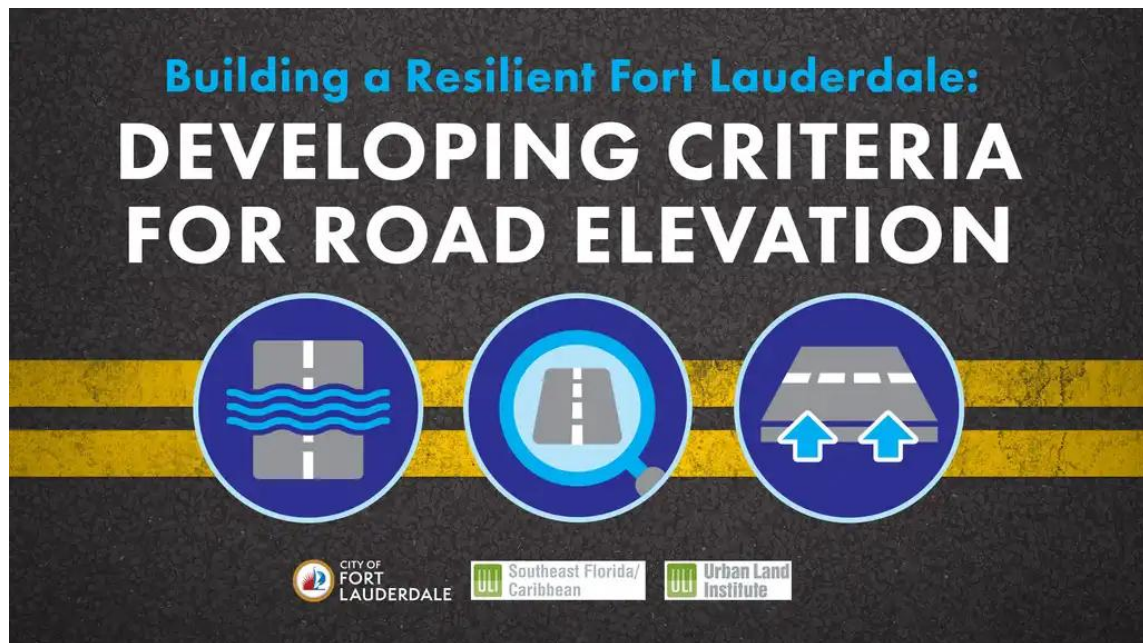

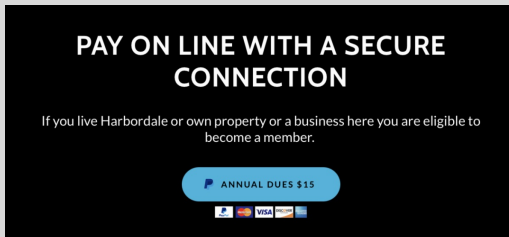
drew residents from many neighborhoods. Concerns were expressed regarding outdoor music on land from bars, water from boats, noisy cars and motor cycles and enforcement.
