- 1. Call to Order and Opening Prayer, John Hilliard asked Lynn Pinson to pray.
- 2. Review and approval of the September 13th, 2022 Agenda Kate Von Glahn made a motion to approve the agenda. Rashelle Minix offered a second. Motion Carried.

a. Finance Committee Meeting Update, Jenny VanMeter

1. Recommendation to implement the new school maintenance program As of the end of September, the contract with Wynn Cleaning Services ends. Put out for bids but none came in. Missy would like to use Cintas for supplies and hire a group of 7 to clean. Gail Amos would oversee that team. An expense summary and comparison was presented to the board. This would be somewhat more expensive than Wynn's Cleaning Service but Missy believes that this will give us more control and we will be happier with this. - 5. Testing/Screeners: Mary Sullivan and Meredith Powell Our cohort since 3rd-5th grade has overall best test scores in elementary school.
- 6. Administrative School Level Reports: Mary Sullivan, Zack Dallas, and Kelly Rucker Kelly feels very positive about math standards coming next year. Teachers are already beginning to train for those. Zack Dallas has been remediating and trying to catch up the kids who are behind. Middle School FFA going very well. 51 Middle School students went to the field trip last week. Tested 12 kids for gifted and have 7 additional new qualified. 12 referrals in elementary school that have yet to be tested. Mary gave a high school report. Remediation day had 50 students and some character development training has been going well. Dr. Winfree has been an incredible asset to the teachers as per Dr. Sullivan. Graphics program is going well and drawing in challenging students who excel when working with their hands. The program is generating lots of interest within the public as well.
