#### 1. PHOTO BOOTH OPERATIONS

#### 2 PHOTO BOOTH SETUP AND REMOVAL

INDOOR VENUES- CLIENT MUST ARRANGE FOR AN APPROPRIATE AREA FOR THE PHOTO BOOTH DURING RENTAL HOURS. THIS AREA MUST BE AT LEAST 10 'FT X 10 'FT AND A MINIMUM OF 8'FT HIGH, ON LEVEL SURFACE, SOLID GROUND, UNDER A COVERING AND AGAINST A WALL TO PROTECT EQUIPMENT FROM WIND, RAIN AND LIGHTNING. THE CLIENTS IS RESPONSIBLE FOR PROVIDING POWER TO THE PHOTO BOOTH WITH 15 FT ACCESS TO A WORKING OUTLET (3 PRONG, 110V, 10 AMP)

THE CLIENT IS RESPONSIBLE FOR ANY DAMAGE CAUSED BY AN IMPROPER POWER PROVISION
