



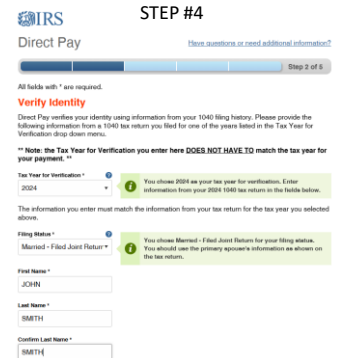
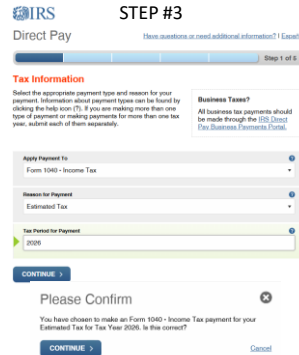
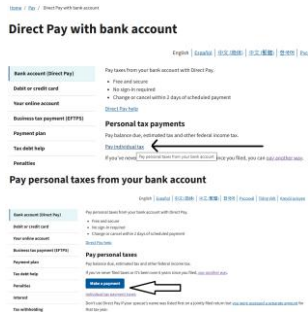
How to Pay Estimated Tax Payments

- Begin at IRS.gov website
- Click “Pay”
- Click “Bank Account (Direct Pay)”
- Click “Pay individual tax”*
- Click “Make a payment”
- *Note: Estimated tax payments are ALWAYS based on your Personal/Individual tax
- Select Form 1040- Income Tax
- Select Estimated Tax
- Select the current year
- You will be prompted to confirm the choices
- Tax year for verification is the previously filed return (e.g. estimated tax payments for 2026 will be verified against the 2025 filing)
- The remaining fields must match EXACTLY to the details of the primary taxpayer of the previous year.

It will be helpful to have your payment voucher with you while completing this process.
