Treasurer Report

- 1. Capital Account Balance-\$8,894.83
- 2. Operating account balance- \$23,096.01
- Accounts receivable- \$290.53
- 4. Fines received in 2021- \$ 10
 Our average monthly bills are \$1940 per month without any repairs or extra fees

Architectural Committee Report

- 1. The Bids have been received for the entry way repair and the SE Corner of the Sooner road fence. \$12,500 for a plaster repair with paint, or \$6,800 for a polymer fill and paint. The Mortar damage on the SE Brick fence will be \$1,000 to \$1,500 to repair. Once the new board is elected and the 2022 dues are received, the repairs can be made in order of necessity.
- 2. Road Repairs- All areas have been identified for repair. Still trying to get quotes and find a good contractor for the entire project
- 3. The wood fence on sooner will be repaired/re-stained on 12/6,7,8/2021. The contractor was asked to return and perform the work at no cost to the HOA due to the fence only being 1 year old. The fence shall be stained on both sides if access was granted to the HOA to enter the backyard.
- 4. Sprinkler Repair at entrance- All lines were repaired, and the zones were verified to be operating with no leaks.

Gate/Access Control

- 1. RFID car Tag audit has been completed; all old homeowners/renters have been removed from system.
- Maintenance contract for gates is now active- Gate company will perform a complete inspection and service of all moving gate parts on a semi-annual frequency.
- 3. Gate code programming will now be handled by our gate company, this will provide accuracy and remove the burden from active board members.
- 4. Gate system should be in good shape for 2022- Entry has two brand new operators, and the exit gates have factory replacement motors/limit switch assemblies.

Website/Communication

- 1. We now have 175 members of the neighborhood that have subscribed to the announcement email feature from the HOA
- 2. A new neighbor presentation and coupon for Marcum's nursery is being sent to each new homeowner that moves into Belmar North
- HOA has received excellent feedback on the new website and the announcement feature for 2021

Board Elections

- 1. There are currently 5 positions that will be up for election in **2022**; President, Vice-president, Treasurer, and Member at Large (2 positions).
- 2. The petitions submitted at the 3rd QTR meeting will require the current President and Vice-President to run for re-election if remaining on HOA board is desired.
- 3. Board Nomination forms need to be returned to HOA email or dropped off at ARIA no later than 1/5/22. Candidates will be given opportunity to speak at the 2022 election meeting
- 4. The 2022 Ballots will arrive in the mail around the second week of January. There will be a section on the ballot that will allow for write-in candidates.

Compliance Committee Report

- 1. Trash Can audit performed for 4th Quarter- 5-9 homes still not in compliance
- 2. Several homes identified for Yard/Fence issues
- 3. HOA thanks all the Homeowners who have been willing to follow the covenants

HOA Dues

- 1. HOA dues will remain at \$220 annually for 2022
- 2. Dues can be paid by check via mail, drop check off at ARIA, or follow the pay dues ONLINE feature that is located on Belmarnorthhoa.com (Online has \$4.95 FEE)
- 3. HOA dues statements will be mailed out after January 1st, 2022

New Business

- Once all HOA Board Nomination candidates are finalized, HOA will explore the possibility of meet/greet before the 2022 elections
- OEC will be contacted to check availability of OEC fiber in Belmar North
- A quote will be obtained to buy speed limit signs to be posted throughout neighborhood, several members expressed concerns about speeding on vista/slater
- Concrete company search will continue, any recommendations are welcome
- Possibility of setting up food truck event, HOA can assist in getting the word out to all members if someone wants to lead the planning effort
- Need announcement for members to help identify construction companies using the Belmar North Entry and Exit gates
