Contractual Obligation Discussions

- ARIA HOA Management Company (ARIA): The current contract for ARIA was reviewed and found to be sufficient. Discussions with ARIA and the Belmar North HOA Board have been productive. A new communication protocol between ARIA and the Belmar North HOA Board has been established to facilitate transparency. The Belmar North HOA Board will review all correspondence from ARIA to any Belmar North HOA member prior to distribution. ARIA has been tasked with the additional duty of maintaining the CAR TAGS for the Belmar North Gate at no extra cost. ARIA will process all payments, and they will distribute CAR TAGS to HOA membership and keep a current database of active CAR TAGS assignments.
- ➤ Gate Operations: The current contract for Gate Operations is under review, and the Belmar North HOA board is currently evaluating proposals from two other companies: PSI and AGR. The Contractual Proposals include Gate Operation, Maintenance/Repairs, and Warranty obligations.
- ➤ Common Areas: The contract for Landscaping is under review, and two other companies are providing proposals that consist of maintenance and upgrades. The fencing updates are complete, and the stucco wall evaluation is ongoing. The Belmar North Board will assess suggestions for improving the Gate Entrance lighting and appearance.

Communication

- ➤ Facebook: The Belmar North HOA Board voted to end open communication on Facebook. The Official Belmar North HOA Facebook account will be used to distribute the HOA Newsletter and announcements for Community Events. All Official Belmar HOA Communication will be posted on www.belmarhothHOA.com. (This will include: Meeting Announcements, Quarterly Minutes, Financial Reports, etc. All complaints, comments, and compliance issues will continue to be transmitted through the ARIA HOA Management Company. The website host is GoDaddy.
- Newsletter- The Belmar North HOA newsletter will contain information about Community Announcements and Events, membership meetings, HOA Board Announcements and feature a Belmar North community member each quarter.
- ➤ Other Correspondence: The Board will post Meeting Minutes, Agendas, and Ballot Measures on the HOA website. All HOA members will receive a pdf copy of the newsletter in email.

Budget Discussion

The new Treasurer, Heather Lawson, will assume the duties of monitoring and reporting budgetary issues and distributing a quarterly fiscal report. The Belmar North HOA Board voted unanimously to remove the previous Authorized Signers on the HOA bank account.

Bank Account and to add President: Andrew Arnold and Dustin Watts as Authorized Signers. The Belmar North HOA Board unanimously voted for a debit card to be issued to the President, Andrew Arnold with all expense spending requiring full board approval. This debit card will remove the current HOA board member's practice to spend their own money and submit paperwork for reimbursement

Compliance Discussion

The Belmar North HOA Board has voted (6-1) to grandfather the existing (29) fences that are not in compliance with the five-foot rule. There was no straightforward procedure for members to submit requests to the HOA Board, because there was no formal Compliance or Architectural Committee. The 2021 Board is instituting a process of Transparency, Communication, and Organization of the HOA Board as stated in the Bylaws. Therefore, rather than penalize 29 homeowners, the board will grandfather all non-compliant fences. Commending on July 31, 2021, when all procedural aspects will be operational, all Requests for Architectural review of fences will be subject to the following process.
