The Board has developed a set of issues that the membership will vote on, and ARIA will set up the voting poll using the client portal to authenticate that each household gets one vote. - 1) LAWN MAINTENANCE

  - b. Are Ivy vines considered to (neat) in appearance IAW Bylaws?
- 2) TRASH CANS
  - a. To keep the trash can rules per Bylaws
  - b. To allow trash cans to be placed on the side of the house with or without fencing.
  - c. To allow trash cans can be kept in the front of the house all week.
- 3) SOLAR LIGHTS
  - a. Allow solar light to be used on walkways and flowerbeds.
- PARKING ON STREET
  - a. Allow parking overnight for one night without prior approval of the HOA Board.
