For our Sunday morning worship, our theme will be "Advent Imperatives!" Here's the lineup for each Sunday:


November 28: "Stay Alert!" Luke 21:25-36





Executive Committee Meeting Highlights

Minutes Executive Committee, Norris Religious Fellowship, 4 November 2021

Members Present: Jocelyn Borgers, Rev. Bill Ireland, Jerry Crossno, Susan Bowling, Louna Kout and Emily Ott. Also present: Joan Hughes, Lee Borgers.

Meeting called to order by Chairman Jocelyn Borgers. Rev. Bill offered a prayer.

- Jerry had modified (corrected) the minutes from the previous meeting by adding the note after Emily's election as vice-chair: "Subject to acceptance by Emily." Minutes were approved with that correction. Emily did accept the office of vice-chair.
- Emily reported that she had made a number of phone calls the discontinue the alarm service by ADT, at one point waiting on the phone for thirty minutes. She thinks that it has been discontinued. Joan will check with Stacy Hauser, accountant, to make sure the church is no longer paying for this service.
- Joan raised the question regarding the fire extinguishers they have not been inspected is a number of years. This was pointed out to her by David Hughes. Joan contacted the fire department (public safety) to see if they could inspect. She has not heard back. Will pursue.
- The parsonage renters are paying \$1,000 per month rent and paying the utilities. They pay the church, which then passes it on. Suggestion was made, that it be set up for the renters to pay those direct, getting the church out of the loop.
- Report from the accountant: As of 31 October, 2021:

Checking/Savings	\$4,570.04
Checking (Paypal)	315.96
Vanguard #1	209,982.90
Vanguard #2	8,816.59
TOTAL	223,685.58

- Jerry pointed out that Vanguard #1 was the Endowment Fund and Vanguard #2 was "excess" funds; i.e. money now necessary for day-to-day operation and invested in Vanguard because it earned more interest that bank interest.
- There was agreement that Stacy (accountant) needs to set up a Balance Sheet of all the church funds.
 This with help from Joan, Jerry and maybe others. As a minimum, this should include: Bldg.
 Maintenance Fund; Endowment Earning Fund; Endowment Principal Fund; General Fund (or operating fund); and Memorial Fund.
- Rev. Bill's *From Here to Tomorrow* meetings will take place next year on 23 January, 27 February and 20 March. Bill expressed his total satisfaction with Ashley, the administrative assistant.
- The new streaming service has been installed, is working and is fully paid for. Bill is working on obtaining a lapel mike.
- The only heat in the offices is portable heaters this has not been satisfactory. Terry Queener is
 working to correcting this. There is ongoing effort to correct the heating in the sanctuary and social
 area.
- Jocelyn, Emily and Bill had a meeting with David Hughes was satisfactory.
- Bill and Genny will have an open house on 19 December.
- Emily moved that we go back to "in-person events." Susan seconded, passed.
- Community Thanksgiving service will be at St. Frances Episcopal Church on 21 November.
- 14 December is schedule for distribution of Good Neighbor's Christmas baskets.
- Church Christmas party will be 5 December. Emily is in charge.
- Jocelyn told Bill that the Trustees (members of the Executive Committee, less the minister) met. There have been no complaints regarding Bill's performance. Thus, the report is basically all OK.
