Re: **Liberal Bias Remains in IRS as Long is Set to Take Over as Commissioner**

Over the past few months, we have documented the heavy liberal bias that remains in the IRS.

With Billy Long Set to take over the agency as Commissioner he can fundamentally transform the IRS into an agency that veers away from its past partisanship by making substantial leadership changes at the agency.

The following list of individuals is comprised of Lois Lerner holdovers, registered Democrats, Democratic donors, individuals who have openly opposed the Trump Administration and supported liberal policies on social media.

**Holly Paz (Commissioner of LB&I)** – Paz was heavily involved in the targeting of conservatives under Lois Lerner and contributed to the lack of faith in the IRS that we see today

**Robert Choi (Commissioner of Tax-Exempt and Government Entities)** – Choi was a deputy to Lois Lerner and took part in the first wave of targeting conservative organizations during the Obama Administration's tax scandal

**Elizabeth Kastenberg (Acting Director of Office of Professional Responsibility)** – Kastenberg took part in the targeting of conservatives under Lois Lerner and admitted that the targeting was due to political affiliation

**Reza Rashidi (Chief Data and Analytics Officer)** – Prolific Democratic Donor

**Kaschit Pandya (Chief Information Officer)** – Kaschit contributed to Joe Biden in the 2020 election cycle

**Jamie Moschella (Director of DFO Transfer Pricing Practice)** – Moschella has supported DEI and Black Lives Matter

**John Wall (Director of Advance Pricing and Mutual Agreement)** – Wall is a prolific Democratic donor and a registered Democrat

**Paul Kruse (Director of Field Operations West)** – Paul Kruse promoted content claiming President Donald Trump is a Fascist

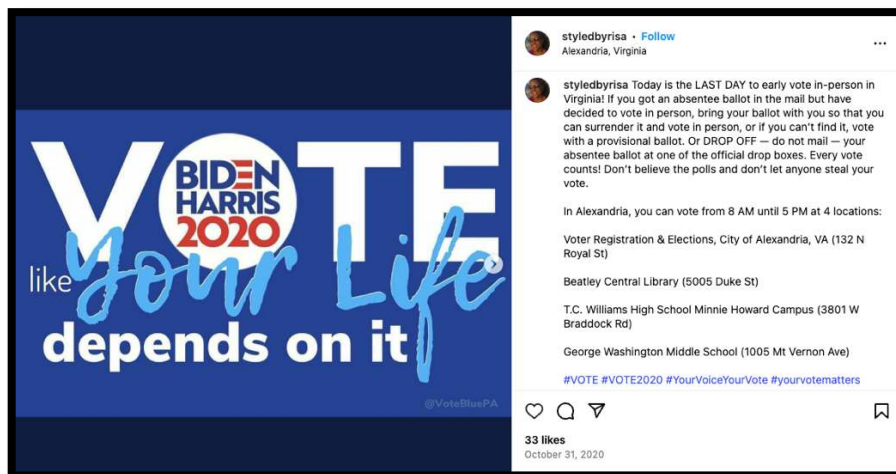

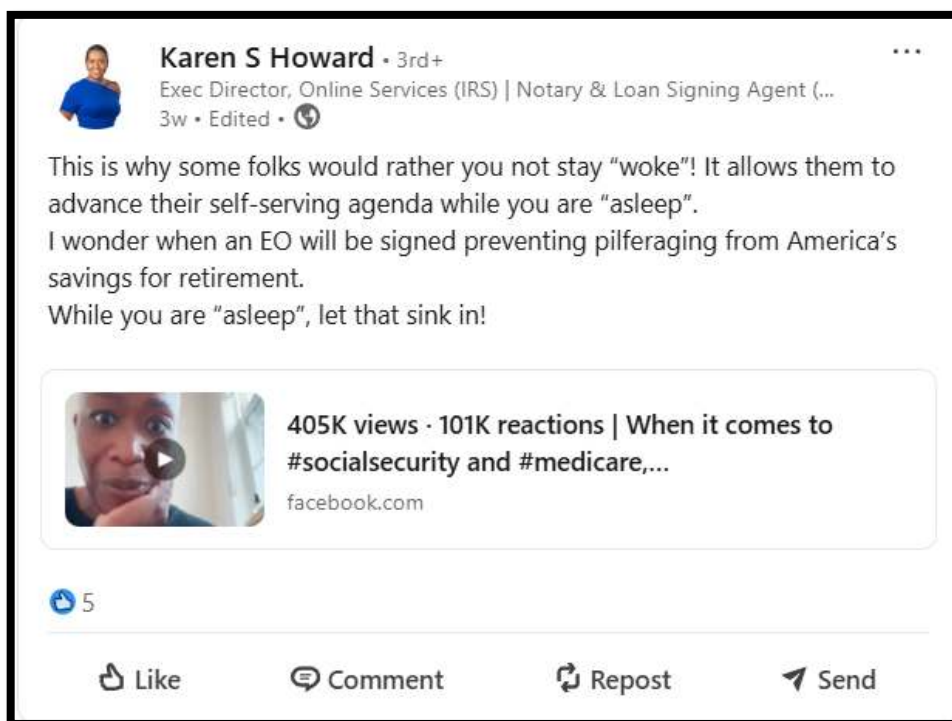

The first phase was our lawsuit, where an NTEU-led coalition of unions argued in court for emergency relief. Although the coalition made a strong case of irreparable harm, the judge unfortunately denied the unions' request, saying that he believed the unions must first bring their case to the Federal Labor Relations Authority (FLRA). NTEU continues to press our case in court.

The second phase is a combination of claims filed at the Office of Special Counsel, Merit Systems Protection Board, and Institutional Grievances. Yesterday, we sent you information on the Office of Special Counsel claim and how you can join that case. Today, we concentrate on Institutional Grievances.

The judge in our lawsuit found that some of our claims must proceed through the FLRA. This means filing grievances, and we have begun these counterattacks through the administrative process.

NTEU will be filing institutional grievances at every agency where probationary and trial employees have been terminated. Those grievances will challenge the agency's actions based on law and contract. Keep in mind: NTEU represents all bargaining unit employees in the 37 agencies and departments where the union is the exclusive bargaining representative.

Bargaining unit employees do not have to take any action to be covered by the union's grievances.

NTEU will request all available remedies under the law, to include returning probationary and trial employees to work. Plus, back pay for those improperly fired.


Right now, our best position to fight the administration's attacks on employees is to use all avenues, including the courts and the grievance-arbitration process. We continue to actively discuss the full scope of our legal options with other unions, like-minded organizations, law firms and coalitions at every level.

Tomorrow, we will send you messaging about the Merit Systems Protection Board—yet another path to vigorously fight back against these illegal terminations.

## Elizabeth C. Kastenberg, Director of Office of Professional Responsibility

### IRS Scandal

#### Directly Reviewed Audits of Conservative Groups

Elizabeth Kastenberg played a direct role in reviewing audits of conservative-leaning nonprofits and was directly involved in the IRS tax scandal that targeted conservatives under Lois Lerner.<sup>24</sup>

*Currently under Whitlock are section manager Elizabeth Kastenberg and legal analysis chief Garrett Gluth, both of whom previously worked closely with Lois Lerner in the IRS's nonprofit tax office. Congressional testimony shows that Kastenberg was in charge of reviewing the audits of conservative-leaning nonprofits and was in the room when major decisions on the political audits were made.*

#### Look Out for Tea Party Cases

In 2010, Kastenberg was told via email to be on the lookout for tea party cases.<sup>25</sup>

## **Was Told To Develop Basis for Denial of Applicants**

Kastenberg was directly involved in a meeting in which she was told to develop another argument to deny two “Tea Party” organizations tax-exempt status.<sup>26</sup>

*Judith Kindell served as Lois Lerner's senior technical advisor. In that position, she advised Lerner on technical issues relating to tax law for exempt organizations, including issues relating to political activities for tax-exempt groups.<sup>135</sup> In April 2011, Kindell reviewed the two test applications and, consistent with Lerner's directive, suggested that the Chief Counsel's office review the cases.*

*By April 1, Carter Hull and Elizabeth Kastenberg had completed their reviews of the test cases and had scheduled a meeting with Kindell to discuss the applications.<sup>136</sup> Kindell met with Hull and Kastenberg on April 7, in which she recommended that they gather more information to develop a basis for denying the applications on another ground.<sup>137</sup> Later that day, she e-mailed Lerner and Paz about the "sensitive (c)(3) and (c)(4) applications," writing:*

*"I just spoke with Chip Hull and Elizabeth Kastenberg about two cases they have that are related to the Tea Party -- one a (c)(3) application and the other a (c)(4) application. I recommended that they develop the private benefit argument further and that they coordinate with Counsel. They also mentioned that there are a number of other (c)(3) and (c)(4) applications of orgs related to the Tea Party that are currently in Cincinnati.<sup>138</sup>"*

## **Kastenberg Took Part in Meeting with Lois Lerner and Holly Paz**

According to IRS employee Carter Hull, Kastenberg took part in at least one meeting with Lois Lerner and Holly Paz in which Lerner wanted “tea party” cases to be referred to as “advocacy” cases.

*In the summer of 2011, I recall attending two meetings related to the Tea Party applications. In July 2011, I attended a meeting at which Ms. Lerner, Ms. Paz, Mr. Seto, Ms. Kindell, Ms. Kastenberg, and someone from Chief Counsel's office were present. Ms. Lerner led the meeting, and she instructed everyone that the applications should be referred to as “advocacy” applications and not “Tea Party” applications.*

## Kastenbergs was Aware of Political Targeting

In 2011, Kastenbergs sent an email in which she admitted cases were being held back based on political affiliation, not political activities.<sup>27</sup>

*But emails released this year show the IRS was made aware by its own agents that it was singling out groups based on their politics, not on questions about their tax behavior.*

*“These cases are held back primarily because of their political party affiliation rather than specifically any political activities,” Elizabeth C. Kastenbergs, an official in the agency’s exempt organizations division, wrote in an April 1, 2011, email to other IRS employees, including her supervisor.*

*That contradicts the long-stated position of the IRS that Ms. Lerner and others involved in the targeting were worried in the wake of a 2010 Supreme Court decision about a surge of groups going beyond the usual rules of politics.*

## Robert Choi, Commissioner of Tax Exempt and Government Entities

### Involvement in IRS Tax Scandal

#### Identified as Director of Exempt Organizations, Rulings Agreements

Choi was identified in a 2014 House Committee on Oversight and Government Reform report as the director of Employee plans from 2011-2013 and director of Exempt Organizations, Rulings and Agreements from 2007-2010.<sup>28</sup>

#### Targeting Began Under Choi

Choi was still the Director of Exempt Organizations, Rulings and Agreements (see above) when the targeting of conservative groups began in 2010.<sup>29</sup>

*February 25, 2010*

*Cincinnati Flags Tea Party Cases: A Cincinnati-based IRS screener initially flags Tea Party applications for “media attention.” The information is forwarded to superiors in Washington, DC, and Cincinnati is told to hold pending further guidance.*

*March-April 2010*

*The Targeting Begins: According to TIGTA, the IRS’s Determinations Unit “began searching for other requests for exemption involving the Tea Party, Patriots, 9/12 and IRC § 501(c)(4) applications involving political sounding names, e.g., “We the People” or “Take Back the Country.”*

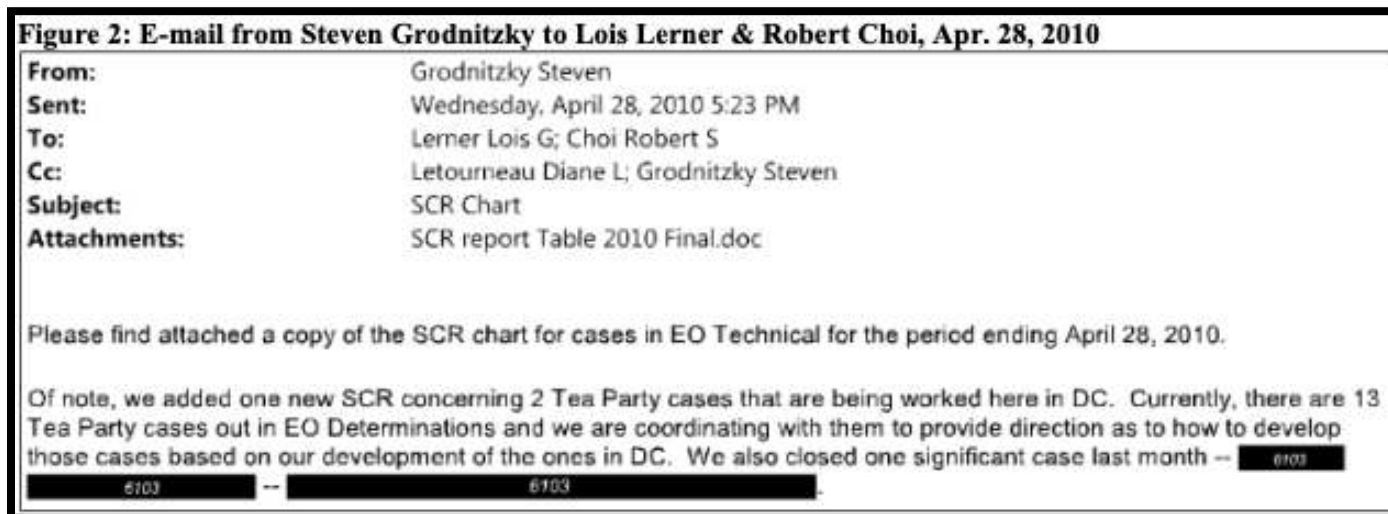

## Email Chain with Lois Lerner

IRS Employee Steven Grodnitzky sent an email to Lois Lerner and Robert Choi concerning Tea Party cases that the agency was working on.<sup>30</sup>



Emails show that Grodnitzky wanted “clearance” from Rob Choi and Lerner before moving forward on any Tea Party cases.<sup>31</sup>

*Later, in May 2010, Lerner acknowledged the existence of the Tea Party applications in response to Grodnitzky's summary chart of sensitive case reports. Lerner wrote to him: "Tea Party cases -- applications for c3? What's their basis?"<sup>96</sup> Grodnitzky responded:*

*"The organizations are arguing education, but the big issue for us is whether they are engaged in political campaign activity. . . I have asked the [tax law specialist] and front line manager to coordinate with Cincy as to how to develop their cases, but not resolve anything until we get clearance from you and Rob [Choi]."<sup>97</sup>*

*In August 2010, after Lerner received another sensitive case report, she asked her assistant to print out the report prepared for the Tea Party applications for her review.<sup>98</sup>*

## Correspondence with Conservative Groups

Choi was identified as having corresponded with the conservative groups that were likely targeted.<sup>32</sup>

*Rep. Charles Rangel, D-N.Y., asked Eastman whether the solution to the IRS misconduct might be to remove its responsibility for determining whether “charitable organizations are being used to get people elected.” Eastman replied, “If we get rid of all tax-exempt status and create a level playing field, that would be fine.”* **Mentioned in oral and written testimony were names of IRS staff in Cincinnati corresponding or talking by phone with the nonprofits, including Robert Choi, Nancy Marks, Sheila May Robinson, Ron Bell, Joseph Herr, Holly Paz and Stephen Seok.** *Rep. Devin Nunes, R-Calif., proposed that all be interviewed or called to testify.*

## Lawmakers Wanted Choi to Testify on Tax Scandal

Choi was singled out to provide testimony to lawmakers regarding the tax scandal.<sup>33</sup>

*Looking ahead, lawmakers suggested the panel should call additional IRS employees to testify or sit for interviews with committee lawmakers, including possibly Robert Choi, the director of an IRS division handing tax-exempt applications and Stephen Seok, an employee in Cincinnati.*

## Connection with Holly Paz

Holly Paz worked under Choi and would later go on to carry out Choi’s role as the director of Exempt Organizations, Rulings and Agreements.<sup>34</sup>

Paz would go on to be placed on administrative leave for her involvement in the tax scandal, but no disciplinary actions took place against Choi – even though the scandal started under his watch.<sup>35</sup>

*Senior Internal Revenue Service official Holly Paz, who helped oversee the agency's internal review of how it scrutinized conservative groups' applications for tax-exempt status, hasn't been formally accused of any wrongdoing. But she has been on administrative leave since early June, and has been subject to harassment after coming under fire from congressional Republicans, according to her lawyer, Roel Campos.*

3) RE "Joe Rogan of the left" -- Some also think it means Democrats need a "Joe Rogan of the left."

But, this misses the mark too. The information landscape is highly fragmented. A single giant player alone won't fix the issue.

What is needed is actually simple: more blue bubbles across many audience segments.

4) RE Resources -- I want to emphasize this is not a resource problem.

Democrats spent billions last cycle on ads. Paid ads have little and diminishing value, especially in such a saturated landscape.

If they spent \$100M of that on storytellers instead, election outcome would have been the same probably. But landscape would look different right now.

Indeed, there is a lot of talk right now about influencers in political circles. But, be careful here and don't be fooled. Much of this talk amounts to simply porting traditional paid media approach to influencer space by way of "pay to post content." This approach not only won't work, but will make problem worse.

5) Fascism is theater -- When Trump first came to power, Fox News and talk radio were the foundations. No doubt. But, over the years, Trump organized power on what used to be considered the fringes. His vehicle for doing that was a massive right-wing media ecosystem -- that yes included Fox and talk radio, but also included this massive online right-wing echo chamber.

There's a reason why so many Trump admin officials are right-wing media fever swamp creatures.

Politics is downstream from culture. The fight for the hearts and minds as well as the future of our society is in the information landscape.

Fascism is theater. And right now, Trump has quite a stage.
