### **NEWS ABOUT CLASSIC COMMUNITIES**

West Hanover Township filed a civil action against Classic Communities for failure to complete the storm water retention pond along Route 39. Classic Communities did not appear at the hearing and the District Magistrate fined them \$12,000. Classic has filed for bankruptcy and the township has engaged legal counsel to determine how much the township will realize from the bankruptcy and from a bond issued by a firm in California. It appears that the township will have to complete the retention pond; however, several issues remain unresolved.

West Hanover Township has not accepted Tiverton Lane as a township road. There are some corrective actions to be taken and it appears that the township may have to correct the problems. The township <u>did</u> plow snow from Tiverton Lane last winter.
