STORM DEBRIS

Hurricane season is fast approaching. The HOA is responsible for removing storm debris from the common areas only. Removal of tree damage and/or debris in a yard is the Homeowner's responsibility. Homeowners can place storm debris out at the curb with their trash but it must be in a container or separately bound with rope or twine.

CHANGES TO THE EXTERIOR OF YOUR HOME

To preserve uniformity in the appearance of our community, please complete an Architectural Change Request Form and send it to the Executive Board prior to making ANY changes to the exterior of your property. Changes include any proposed construction, planting, paint and/or stain and installation of storm doors.

It's not a complicated process. The form is available from any member of the Executive Board. You can give the form to any member of the executive board, or mail it to the association at Post Office Box 6353, Harrisburg PA 17112-0353.

PET OWNERS - YOUR ATTENTION PLEASE

Please remember that you are responsible for picking up your pet's "deposits" at any point in the community, to include both in front and at the rear of houses. Pets should always be on a leash and not allowed to run free unless in your own fenced in yard.

FLOWER AND SHRUB BEDS

If you plan to make modifications to the flower and shrub beds at your home, please complete an Architectural Change Request Form and send it to the Executive Board prior to making any changes to the beds. The maintenance of the plantings will be your responsibility. For uniformity of color, the landscaping contractor will apply mulch to shrub and flower beds at the front and side of your home and will edge the beds as provided for in our contract. The maintenance of flower and shrub beds at the rear of your home will remain your responsibility.

DRAINAGE EASEMENT REPAIRS

As you probably have noticed, another attempt is being made by Classic Communities at the direction of the Township to improve the drainage easement that runs behind the homes located on Brookridge Court. Hopefully, this time it was done correctly. If we get a dry spell, it is the adjoining property owner's responsibility to water the new grass seed that has been planted.

SNOW REMOVAL

It may be a little early for this but when a snow storm is forecast, please make every effort to park your vehicles off the streets in your garage or driveway. This will enable the plow crew to clear the entire street. Plowing of Brookridge is the Township's responsibility. Plowing of Tiverton is still Classic's responsibility. We have contracted with Hoagy"s Landscaping to remove snow from the sidewalks and driveways in the event we have 3 or more inches of snow.

PARKING

Everyone should be aware that parking in the cul-de-sacs on Brookridge or Tiverton is not permitted. This is a Township requirement based upon the turning radius of the cul-de-sacs and the inability of emergency vehicles to make the turn if there are parked vehicles. Please also be mindful when parking on the street that it is difficult for emergency vehicles to get through if vehicles are parked directly across from each other and not tightly against the curb.
