SNOW REMOVAL

Hoagy's Lawn Care Service Inc. will be offering snow removal services for individual residents of The Townes at Hershey Road for snow events <u>less</u> than 3 inches. Winter events over 3 inches will still be an automatic service of the entire community.

Price: \$40.00 for snow removal service under 3 inches of accumulation per This price includes snow event. removal from the driveway, in front of the garage, and sidewalks and steps leading from the driveway to the front door. To request snow removal service please TEXT MESSAGE a request for service to 717-773-5463 on the day of a winter event as soon as possible. Please include the NAME. ADDRESS of the property in the TEXT MESSAGE so that it can be scheduled. Snow Removal will not be automatically provided to individual homeowners for events under 3 inches. We must receive a TEXT MESSAGE request for each snow event. (Some homeowners require service at varying accumulations.) Payment: Hoagy's Lawn Care Service Inc. will submit a monthly invoice to the homeowner for the amounts properly due under this

agreement. Invoices are to be paid by the homeowner within 30 days of receipt. The Contractor reserves the right to invoke a late fee on all invoices paid after 30 days of invoicing.

MONTHLY DUES INCREASE

In 2006, when Classic Communities operated the HOA Executive Board and there were no homeowners on the board, the monthly HOA dues were raised from \$69 per month to \$95 per month. When the homeowners took control of the HOA in 2010, the new elected HOA Board found that the management company that Classic Communities had hired was an excessive expense and did not renew their contract.

We began doing our own accounting and administration and, as a result, we were able to have a "dues free" month in December for a few years. As our expenses slowly increased, the "dues free" month was eliminated and with conscientious management, we were able to hold our dues at \$95 per month for over 12 years. However, due to increases in operating expenses forecasted for 2019, the HOA board has no choice but to increase monthly

HOA dues starting in 2019. contracts with Hoagy's Lawn Care for snow removal expired last spring and the landscaping contract is expiring at the end of this year. The Board sent snow landscaping and removal contracts out for bid to several landscaping companies in the area. Hoagy's Lawn Care sent proposals for 2019 and 2020 landscaping and snow removal that included price increases in almost all categories services. This would be their first price increase in five years. Hoagy's Lawn Care's last increase was in 2013. Only one other landscaping company returned proposals for landscaping and snow removal services and their prices in nearly every category of service were nearly double Hoagy's new negotiations After prices. Hoagy's Lawn Care, the Board voted to accept Hoagy's Lawn Care proposal for the 2019 and 2020 landscaping seasons and snow removal proposal 2019-2020 winter snow the removal season. If we were to use the Consumer Price Index as our guide, going back to 2006, our dues could be raised to \$126 per month. However, the HOA Board has voted in increase the dues by only \$10 per month for 2019. Thus, effective January 1, 2019, The Townes at Hershey Road HOA dues will be increased to \$105 per month. This will be reflected on the monthly statement you will receive in December. For those who pay their HOA dues on an annual basis, this works out to \$1,260 for 2019. Your HOA Board has worked diligently to keep costs down and will continue to work to hold expenses in check.
