## WEST HANOVER TOWNSHIP

#### FEASIBILITY STUDY

The concept of a new West Hanover Township Administration Building has been discussed multiple times over the last several years. The need for a new building is evident in that the current building requires substantial investment in its mechanical systems, public meeting space, Americans with Disability Act Upgrade Requirements and security.

The question becomes does the Board look at renovating and adding to its current location or does the Board evaluate other options.

Earlier this year the Board of Supervisors hired the Architecture Firm of Kimmel Bogrette to conduct a feasibility study to evaluate Township owned facilities and properties for their suitability for the placement of a new Township Administration Building and Public Works Complex. At the July 15th Supervisors meeting the Architect presented three options. Of these three options, the Supervisors directed the Township Manager to evaluate Option C further. This option appears initially to provide for the future needs of the township for the lowest cost of the other options.

The new construction is also anticipated to include, on the same site, a new Public Works facility as well. The new Administration Building is also being developed to include space for the Recreation Department as well as the Sewer Authority, if necessary. With all Township administration and operations together in one location it will be much easier and streamlined for Township residents to complete their business with the Township. There are also significant operational efficiencies that will precipitate from this that the cost of running the township will decrease significantly. While we are still very early on in the conceptual and planning phases, it is anticipated that current revenues will support the cost of construction.

#### EXPANDED TOWNSHIP BUILDING HOURS

The expanded Summer hours for the Township Building have been made permanent. We will be open weekdays from 7:30 a.m. until 4:30 p.m.





#### West Hanover Big Tree News

In November, 2020 the EAC Big Tree Task Force visited Ann Markley's beautifully maintained home and gardens. The property is the former home of the Morris family. We measured an American Holly, a Boxwood and a Northern Catalpa tree. Although none were exceedingly large, they were all added to the West Hanover Township Big Tree Registry.

More recently, the Task Force measured a large Northern red oak on Jim Bailey's property, and added it to the registry. Jim is a dedicated steward of his trees, as he plants and cares for many. He's also very proud of a large walnut tree about half a mile north of his home. We measured the walnut to be 10.25 feet in circumference.

Anyone interested in proposing a tree for West Hanover's Big Tree Registry may pick up a brochure at the Municipal Building, or download it at the Big Tree Registry Link (under Government: EAC) at westhanover.com. After the owner's permission is received, EAC members will arrange to visit the tree, photograph it, and record it's measurements. The data collected will be used to calculate a champion tree point score, which will be compared with the trees listed on the PA Big Tree website.

All trees that are recorded by this method will be added to the West Hanover Township Big Tree Registry. If the tree appears to be a candidate for the PA Big Tree List, the property owner will be encouraged to submit the application to the PA Forestry Big Tree Coordinator. 

#### CODES CORNER

**BUILDING PERMITS** Residents are reminded that ALL building permits require a FINAL INSPECTION to closeout the permit. It is the homeowner's responsibility to make sure a final inspection is scheduled and completed. If you sell your home, buyers may want to see any Certificates of Occupancy that you have for any additions or structural changes you made while owning the home, before you go to close on the home.

Anyone buying or selling a home in West Hanover Township will need to provide a copy of the stormwater fee to the settlement company.

**BURN PERMITS** A Burn Permit is necessary anytime you want to burn on your property. The permits are only valid for one burn. Each individual burn requires a new, signed permit. Burn permits are available at the Township Building and on the Township website. If caught burning without a permit, or burning items that are not allowed, you will be subject to legal action.

**COMPLAINTS** All complaints must be submitted to the Township in writing on a Township issued Complaint Form. Forms may be picked up at the Township Office, or downloaded from the website at www.westhanover.com. All Complaint Forms must be filled out completely and signed by the resident. The Township will not investigate any anonymous complaints.

**FRIENDLY REMINDER** All properties with on-lot septic systems must have their systems pumped every four (4) years. A report from the pumper/hauler must be sent to West Hanover Township. Please call the Township at 717-652-4841 for a complete list of licensed pumper/haulers.

**ANIMALS RUNNING AT LARGE** It shall be unlawful for the owner of any dog, cat, or domestic pet, to run at large either upon the public streets or highways of the Township, private property of any other person or upon any other property not belonging to, or in the possession of, the owner of such animals or to persons under whose supervision or control such animals are being kept.





#### TRAVELING DURING COVID-19 submitted by Jay Megonnell

Fall is a popular time for traveling. Now that many have been vaccinated for COVID-19, some are feeling the desire to travel again. The Centers for Disease Control and Prevention (CDC) recommends delaying travel until you are fully vaccinated, and provides guidelines for traveling during the pandemic.

#### Domestic Travel during COVID-19:

If you are fully vaccinated, continue to take caution when traveling. Wear a mask on planes, buses, trains and other forms of public transportation, such as airports and stations. Comply with all state and local requirements, including mask wearing and social distancing. Upon return from travel, self-monitor for COVID-19 symptoms and isolate and get tested if you develop symptoms. Follow all state and local recommendations and requirements.

If you are not fully vaccinated, you are encouraged to take a viral test 1-3 days before your trip. Wear a mask on planes, buses, trains and other forms of public transportation, such as airports and stations. Avoid crowds and stay at least six feet from anyone who is not traveling with you. Wash your hands often or use hand sanitizer with at least 60% alcohol. When you return from travel, take a viral test within 3-5 days and stay home and self-quarantine for 7 days after travel. Even if you test negative, stay home and self-quarantine for seven days. If you test positive, isolate yourself to protect others from getting infected. If you don't get tested, stay home and self-quarantine for 10 days after travel.

#### **International Travel during COVID:**

Fully vaccinated individuals are less likely to get and spread COVID-19. But, international travel presents additional risks. Even fully vaccinated travelers might have greater risk for getting and potentially spreading COVID-19 variants. The spread of new variants differs from country to country and travelers should pay close attention to the conditions at their destination before traveling. The CDC continues to update recommendations as more people get vaccinated, rates of COVID-19 change and more scientific evidence is available.

Understand and follow all airline, transportation and destination requirements regarding mask wearing, testing, or quarantine, which may differ from U.S. rules. You may be denied entry and have to return to the U.S. if you do not comply with international guidelines.

All air passengers coming to the U.S., including fully vaccinated people, are required to have a negative COVID-19 test result no more than three days before travel or documentation of recovery from COVID-19 in the past three months before entering the U.S. When you return to the U.S., get tested with a viral 3-5 days after traveling. Self-monitor for COVID-19 symptoms, isolate and get tested if you develop symptoms. Follow all state and local recommendations after travel.

Whether your plans are domestic or international, do not travel if you were exposed to COVED-19, you test positive for COVID-19, you are sick or are awaiting test results. Avoid traveling with someone who is sick. For more information on when to delay travel, visit:


