## New Municipal Complex Update

These are some exciting times for West Hanover Township residents. After a little over two years of planning, public meetings, discussions and Supervisor scrutiny we have crossed yet another major milestone. Recently, at the February 15<sup>th</sup> Supervisors meeting, the Board voted to accept the bids for the construction of the new Municipal Complex. This obviously is the biggest step forward and the Township is financially well positioned to construct this project.

Many Supervisors both past and present have recognized a need for this project over the decades and there is a mutual consensus that something needed to be done. The Board of Supervisors tasked the staff to look at all possibilities of township needs and what could be accomplished.

Over this 2-year process the cost of the project rose above the original budget. While staff, construction manager and the architect implemented value engineering processes to ensure cost containment, rising inflation and supply chain issues caused the project to come in slightly over budget. Fortunately, we anticipated that with budgeting contingencies.

So next steps. While we proceed through the contractor award and construction contracts phase, we anticipate breaking ground the end of April or early May. The construction phase will proceed through the winter and into 2025 with an anticipation of occupancy late spring or early summer of 2025.

We look forward to welcoming everyone to the new complex and finally closing out this project for our residents.

## West Hanover Township Receives \$80,000 Greenways, Trails, & Recreation Program Grant to Develop Trail Network Plan

On January 16, 2024, West Hanover Township was awarded a \$80,000 Greenways, Trails, and Recreation Program (GTRP) grant for the development of a study to evaluate potential trail network connects throughout the township.

The Township currently has a fragmented park system that was developed over a long period of time, largely without the benefit of a comprehensive trail network plan. As a result, the park system is not in line with the current or future needs of township residents. A comprehensive plan would help remediate this problem. Additionally, it is a high priority for the township as it will support improved outdoor recreation and citizen health and well-being, as well as the desirability of the township as a place to live and work.

“On behalf of the township, we would like to thank Rep. Kerwin and Sen. DiSanto for their support of this important community project,” said Township Supervisor and Board President Gloria Zimmerman. “It furthers the Township’s desire to create opportunities for trail alignments and enhancement, as well as the expansion of sustainable green climate mitigation measures.”

Residential and commercial growth throughout the township is expected to continue at its fast pace. The Township must take the time now to learn the priorities of citizens with regard to greenway preservation and connectivity so that priority areas can be protected from new development before it is too late. A comprehensive plan is also needed to ensure future residential and commercial developments incorporate recreational features in line with the township's needs.

The GTRP program is used to fund projects which involve development, rehabilitation, and improvements to public parks, recreation areas, greenways, trails, and river conservation. It is funded through the Act 13 Marcellus Legacy Fund program under the Commonwealth Financing Authority (CFA). The Act 13 programs are highly competitive, and the CFA received eligible requests totaling an estimated \$88 million for the approximately \$22.9 million that was available.

## ***CODES CORNER***

**COMPLAINTS** All complaints must be submitted to the Township in writing on a Township issued Complaint Form. Forms may be picked up at the Township Office, or downloaded from the website at [www.westhanover.com](http://www.westhanover.com). All Complaint Forms must be filled out completely and signed by the resident. The Township will not investigate any anonymous complaints.

**ANIMALS RUNNING AT LARGE** It shall be unlawful for the owner of any dog, cat, or domestic pet, to run at large either upon the public streets or highways of the Township, private property of any other person or upon any other property not belonging to, or in the possession of, the owner of such animals or to persons under whose supervision or control such animals are being kept.

**FRIENDLY REMINDER** All properties with on-lot septic systems must have their systems pumped every four (4) years. The pumping deadline is based on precincts. There are 4 precincts. If you are unsure of which precinct you are located in, or have any questions, please contact Sharmaine at 717-652-4841 ext. 103. A report from the pumper/hauler must be sent to West Hanover Township. Please call the Township at 717-652-4841, ext. 103 for a complete list of licensed pumper/haulers.

**BUILDING PERMITS** Residents are reminded that ALL building permits require a FINAL INSPECTION to closeout the permit. It is the homeowner's responsibility to make sure a final inspection is scheduled and completed. If you sell your home, buyers may want to see any Certificates of Occupancy that you have for any additions or structural changes you made while owning the home, before you go to close on the home.

Anyone buying or selling a home in West Hanover Township will need to provide a copy of the stormwater fee to the settlement company. Call Keystone Collections at 724-978-0300 for the certificate.

**Inspection Schedule (starting 01/30/2024)** We do not inspect on Monday or Thursday.

**Tuesday** - Both am and pm times. NO commercial. NO ADA/accessibility

**Wednesday** - All inspections/both am and pm times.

**Friday** - Both am and pm times. NO commercial. NO ADA/accessibility

**Re-inspections:** This is a failed inspection that requires a separate trip to re-inspect. Must be paid PRIOR to the release of the CO/completion certificate.

Residential/per inspection \$80.00

Commercial/per inspection \$130.00



## ***CODES CORNER continued***

### **ALL PERMITS REQUIRE A FINAL INSPECTION - NO EXCEPTIONS**

All inspections are mandatory. A final inspection is required for every permit. See paragraph (b) as *all* inspections must be scheduled by the permit holder or their authorized agent (contractor).

PA Uniform Construction Code / Article 403.64

(a) A construction code official shall inspect all construction for which a permit was issued. The permit holder shall ensure that the construction is accessible for inspection. An inspection does not bar prosecution or other legal action for violation of the Uniform Construction Code.

(b) The permit holder or an authorized agent shall notify the construction code official when work is ready for inspection and provide access for the inspection.

(c) The construction code official shall notify a permit holder if construction complies with the Uniform Construction Code or fails to comply with the Uniform Construction Code.

(f) A construction code official shall conduct a final inspection of the completed construction work and file a final inspection report that indicates compliance with the Uniform Construction Code.

#### Common fails for pools (both in-ground & above-ground):

**Note: ALL permits require a FINAL inspection. Pools may have multiple contractors (i.e. fence, pool co, etc.)**

**ALL of these items are required for the CO.**

1. The pool barrier is incomplete. For in-ground pools, the perimeter fence must be complete.
2. Any gates in the fence must swing open away from the pool. When released, the gate must close and self-latch.
3. Any doors and any windows within 6FT of the ground that are common to the enclosed area must have a UL2017 compliant alarm. This listing must be part of the alarm.
4. For above ground pools, the top of the pool sides must not be within 48" of the ground in any dimension.
5. Decks or stairs providing access to an above ground pool must comply with the pool barrier requirements.

***Finally, reminder emails or letters will be out for all building/demolition/electrical permits issued that have not had a final inspection. These are just to close the permits out and there are not additional fees for a forgotten permit, unless you fail an inspection.***

#### **TEMPORARY BERM RAMPS**

Temporary berm ramps are not permitted in the Township right of way. These have been used to prevent vehicles from dragging on the apron of the driveway. Aprons that are too high from the street can be fixed permanently.

### MOWING REQUEST

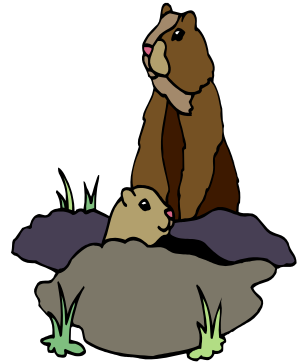

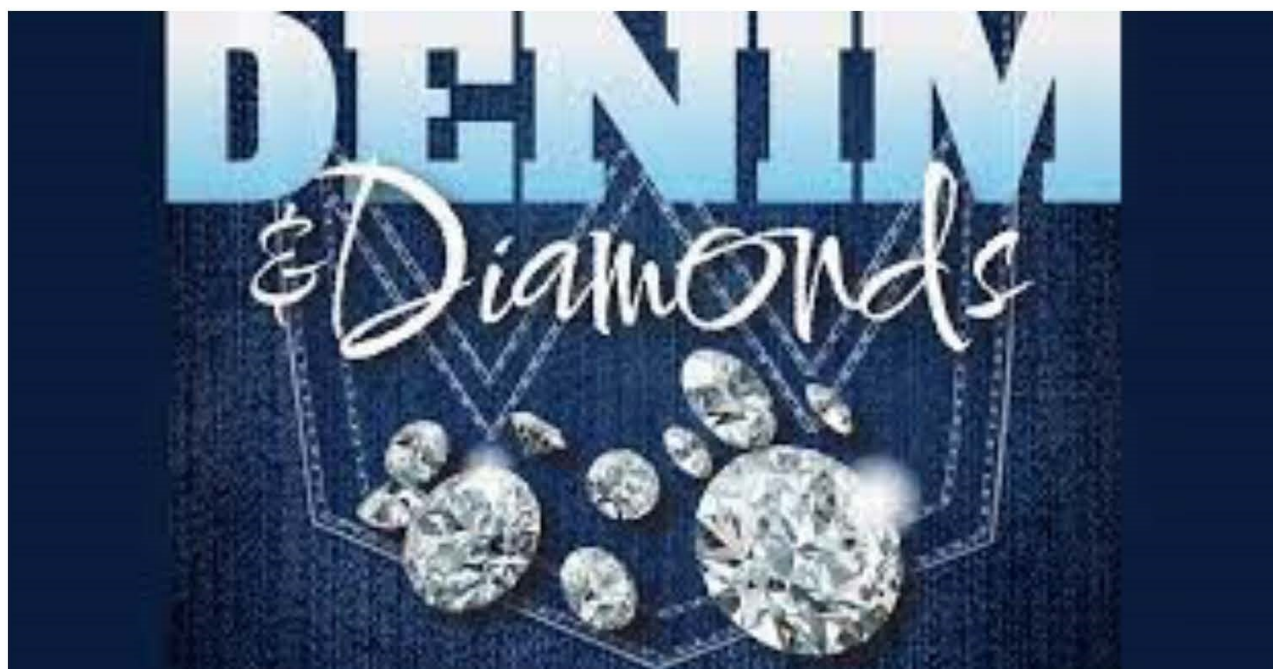

## Stormwater Update

Annual stormwater bills are expected to go out to parcels Mid-March. Please be on the lookout for your bill coming from Keystone Collections. We will post an update on our website and Facebook pages when they are going in the mail. Make sure all stormwater bills are paid from all previous years (2020, 2021, 2022, and 2023). Credits are not applied to delinquent accounts. If you are unsure if your bills have been paid, you can call Keystone Collections directly at 866-539-1100. We cannot accept payments at the Township office.

We are continuing to work with our Solicitor, Salzmann Hughes, and Keystone Collections on collecting delinquencies. Liens have been placed on selected parcels and more liens will be placed on other delinquent parcels. If you have received correspondence from the Authority and Salzmann Hughes, we encourage you to pay your fees. If you do not pay your stormwater fees, you will incur other legal and lien fees that will more than double some of the bills. Aside from this expense, not paying your fee burdens your fellow residents. As we have mentioned many times, please understand the Township is mandated by the State and Federal government via our MS4 permit.

The Authority is working on our potential third stream restoration project, which will be the Unnamed Tributary to Manada Creek by the Sewer Authority. We are currently under a 30-day public comment period (February 13 - March 14) to review the amended PRP plan from our original stream restoration project at Lakeside Avenue that fell through. A copy of the amended PRP plan is available at the Township Building and, on our website, where you can submit your comments, if you have any. The next monthly stormwater meeting is on March 13<sup>th</sup> where there will be a public comment opportunity.

The Authority has joined the Water Resource Enhancement Program (WREP) with the Tri County Regional Planning Commission along with several other municipalities and boroughs in the area. This program allows all participants to work together on projects, public outreach, etc. which can boast a cost savings.

Monthly stormwater meeting are held at the Administration Building the second Wednesday of the month at 6:00 pm or on Zoom. We encourage all to attend!

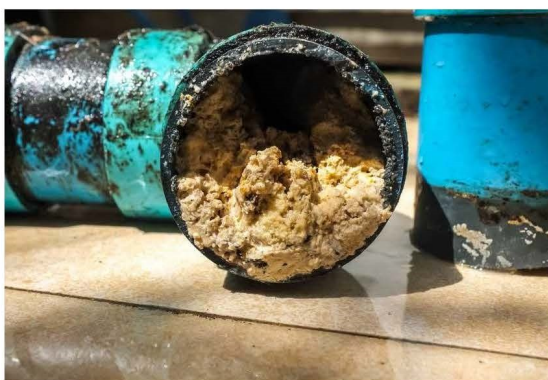


## Down the Drain: Tackling Challenges in Sewer Systems

Sewer systems, the silent backbone of modern living, face an adversary that threatens their smooth operation: grease. This article explores the impact of grease on sewer systems, the associated challenges, and potential solutions to overcome its effects.

Often originating from cooking and food preparation, grease appears harmless when washed down the drain. However, within sewer systems, it transforms into a formidable enemy. Over time, grease solidifies, forming obstructions in pipes, known as "fatbergs," causing severe blockages and disrupting wastewater flow.



This accumulated grease in sewer pipes congeals with other debris, creating blockages that lead to service interruption, backups and possible overflows. This poses not only environmental and public health risks, it can also corrode pipes, reducing their lifespan and increasing maintenance costs for ratepayers.

While service interruption is inconvenient, overflows are even worse. They release untreated wastewater, laden with grease and contaminants into the environment, endangering our streams and rivers and compromising drinking water sources.

Luckily, we aren't just victims in this story as there are ways we can fight back! Installing grease traps in commercial kitchens can intercept and contain grease before it reaches the sewer system, but these require regular maintenance and cleaning to work properly. As a homeowner, being careful about what you put down the drain can help as well.

When cooking, pour grease into a dry, empty jar, can or cupped aluminum foil and then allow it to cool. Once it has solidified, throw it away with your regular trash. By doing this and avoiding flushing items like "flushable wipes" (they aren't!) and sanitary products, we can all help keep these blockages from forming in the first place.

### ***If in doubt, throw it out!***

In the coming months, as the weather warms up, you may notice Sewer Authority employees out in the field conducting inspections of sewer lines and commercial grease traps in order to protect our public sewers from the impacts of grease and other contaminants. By performing these inspections, we can ensure the efficiency and longevity of our sewer systems, keep costs down and protect the public health and the environment.

## Neighbors,

If you believe that crazy groundhog, then Spring will be upon us on the earlier side this year. I hope he is right because I am tired of the cold! We have a lot to do this year in the parks. The Parks & Recreation Board is currently working to design a restroom facility to be installed at Fairville Park. Mt. Laurel Park construction will continue into 2024 as we work to make electrical, plumbing, and structural repairs and upgrades. The Board is also working on a Master Plan for the park. We are currently working with our local Boy Scout and Girl Scout Troops to perform service projects in the parks, including a shelter along the nature trail at Fairville Park and a Community Garden at Mt. Laurel.

We are gearing up for our Summer Recreation Camp Programs for this year and are excited to introduce a half-day camp at Skyline Commons Park.
